**GRAND MASTER'S ADDRESS.**

THE M. W. the Grand Master delivered his Annual Address as follows:

*Right Worshipful, Very Worshipful, and Worshipful Brethren:*

Another year has passed away, with its trials, its privileges, and its mercies, and it now becomes my duty, as well as my pleasure, to bid you welcome to this, the 23rd Annual Communication of Grand Lodge.

While the year just passed has not been marked with any extraordinary event in the history of our Craft, harmony, peace and unity have prevailed within our borders — a subject for devout thanks to the Grand Architect of the Universe.

In accordance with the resolution of Grand Lodge, I forwarded to the M. W. Grand Master of the Grand Lodge of New York a telegram congratulating him on the success of the effort which had freed the Craft in his jurisdiction from the burden of indebtedness on their Masonic Temple. This message was duly recorded in our proceedings of last year. The following courteous acknowledgment was promptly received:

NEW YORK, April 25, 1889.

Immediately after our last Annual Communication I left the Province on a trip to Great Britain. This visit was full of Masonic interest to me. From many of our Scottish and English Brethren I received many courtesies which I here gratefully acknowledge. Specially would I mention the warm Masonic greeting I received from our late lamented representative near the Grand Lodge of Scotland, W. Bro. James Webster, at that time Worshipful Master of Edinburgh Lodge, No. 1. During my stay in London, W. Bro. Wm. Masters, a Past Master of Peace and Harmony Lodge, No. 60, laid me under special obligations by his hospitality and courtesy. Through the kindness of Colonel Shadwell Clerke, Grand Secretary, I had an opportunity of admiring the magnificent room in which the Grand Lodge of England meets. This hall, destroyed by fire in 1883, has been completely restored, and repainted portraits of their illustrious Grand Masters again adorn the walls.

But chiefly did I envy our English Brethren their grand system of Masonic benevolence, and ardently did I long for the day when the Craft in this jurisdiction, freed from debt, may inaugurate a humble imitation of these noble charities.

During my three months' absence the interests of the Craft were well and carefully guarded by the R. W. Deputy Grand Master, Bro. G. M. Jarvis.

It is with feelings of the deepest sorrow that I announce that, since our last Annual Communication, several illustrious members of this Grand Lodge have been stricken down by the all devouring scythe, and gathered into the land where our Fathers have gone before us. For the first time in our history we are called upon to mourn the loss of one of my predecessors in this chair. Past Grand Master B. R. Stevenson died at his residence, St. Andrews, January 16, 1890. None of our members were better known or more highly esteemed than he. Genial in his manner, enthusiastic in his Masonic work, regular in his attendance at our meetings, it was in no way strange that from the first formation of this Grand Lodge Bro. Stevenson should have merited more than ordinary distinction. It is not necessary that I should enter into any lengthened eulogium of his many virtues, public and Masonic. His best monument will be found in the sorrow and loving remembrance of his Brethren.

On the 26th day of August last, V. W. Bro. Rev. Charles S. Medley, a Past Grand Chaplain of this Grand Lodge, was called to rest eternal. Gifted beyond most men with rare qualities of heart and mind, he adorned the sacred profession to which he had devoted himself. While working with untiring zeal and energy for the salvation of souls, he never failed to recognize the claims of friendship and brotherly love. His Christian patience, through more than ordinary suffering, was wonderful to see, and those of us who saw much of him during his last days cannot mourn inconsolably that his earthly fight is o'er, his immortal reward begun.

R. W. Bro. Archibald McLean, a Past Master of the Union Lodge of Portland, and Past Junior Grand Warden, died in this city March 16th, 1890. A warm-hearted and enthusiastic Mason, he had deservedly won the esteem and respect of his Brethren. Regular in his attendance at the stated meetings of his Lodge, active and energetic in Craft Masonry, he has set an example for those who come after him.

But a few days since we were intensely shocked to learn of the sudden death of a venerable member of the Fraternity, R. W. Bro. Bliss Botsford. This sad event, which called forth many expressions of sorrow and surprise, was the result of an accident. Judge Botsford, belonging to one of the oldest and most honored families in the Province, and occupying a high judicial position, was naturally a leading man in the community.

We also mourn the sudden loss of our representative near the Grand Lodge of Scotland, W. Bro. James Webster.

Also the demise of V. W. Bro. T. B. Pardee, our representative near the Grand Lodge of Canada.

R. W. Bro. C. M. Chambers, our representative near the Grand Lodge of British Columbia, has died during the year.

On the 13th of June there was received a communication from the V. W. Bro. T. H. Lempriere, Grand Secretary of the United Grand Lodge of Victoria, announcing the formation at Melbourne of that Grand Lodge on the 20th day of March, 1889. M. W. Bro. the Hon. Sir W. J. Clarke was duly elected and installed first Grand Master. The communication, in asking for fraternal recognition, goes on to state that "The whole of the proceedings in connection with the United Grand Lodge of Victoria were carried out in a legal and constitutional manner. Of 142 Lodges in this Colony, heretofore under English, Irish, Scotch and Victorian Constitutions, 140 have given in their allegiance to the United Grand Lodge."

In connection with this matter I would call your attention to a report of the Committee on Recognition of Sister Grand Lodges, pre-

sented to this Grand Lodge at the Annual Communication of 1884, and which deals with the claims for recognition by the then Grand Lodge of Victoria. At that time the Committee reported adversely to the application for recognition by the Grand Lodge of Victoria, not so much on the ground of any irregularity in its formation, as from a lack of unanimous action among the Lodges occupying that territory. The same objection cannot, I apprehend, be urged against the recognition of this new Grand Body.

On the 13th of July I received a communication from M. W. Bro. James W. Cloes, Grand Master of the Grand Lodge of North Dakota, informing me of the organization of that Grand Lodge, on the 13th day of June last. This Grand Lodge was erected in consequence of the division of the Territory of Dakota, and has been fully recognized by the M. W. Grand Lodge of Dakota. By my direction the Grand Secretary has handed these communications to the Committee on Relations with Foreign Grand Lodges, and I have no doubt they will recommend to you the immediate recognition of the Grand Lodge above mentioned.

Few cases have been referred to me during the year, either for decision or advice. The most important are as follows:

July 10th, I received through the Grand Secretary's office a communication from Lodge St. Andrew, No. 16, asking decision as to the reception of certain petitions.

It appeared from the correspondence that the petitioners were natives of Richibucto, and had lived there until over the age of twenty-one. They had then gone to Boston, where they had lived and worked for some six years past, coming to this Province occasionally to visit.

Now, the question is, where does the right exist to make Masons of these applicants? In support of the right of Lodge St. Andrew it was urged that the fact of their having resided in Richibucto until over twenty-one years of age brought them within the meaning of that section of our Constitution (Sec. 2, p. 42), which says, "Except in cases of seafaring men, no person shall be made a Mason unless he has resided one year in the jurisdiction of the Lodge to which he seeks admission, or shall produce a certificate of character from the nearest Lodge to the place of his previous residence."

It appeared to me that the true spirit of the Constitution was that the year mentioned was the year immediately preceding the date of the application. The intent of the law is to guard the Craft against the admission of unworthy members, as well as to maintain the right of jurisdiction.

If a previous residence in years gone by gave the right to receive a candidate, all knowledge of his true character might be wanting, as

circumstances might have subsequently arisen which would make him an undesirable member. Then again it must be clear that the right to receive cannot exist in two places. From the evidence as stated, I do not think it could be successfully controverted but that the legal residence of the petitioners was in Boston, and, if so, the right to receive and initiate would lie with one of the Lodges there. While, therefore, I had the strongest sympathy with the desire of these worthy young men to seek admission to the Craft at the place of their birth, I had to decide that Lodge St. Andrew could not receive and initiate these candidates unless by consent of and with the certificate of one of the Lodges of the city of Boston.

Grand Master McNichol, in his Address of last year, states a case apparently exactly similar, where Campbellton Lodge initiated a resident of Wisconsin while home on a visit. The Grand Lodge of Wisconsin called attention to this, and our Grand Master, on investigating the circumstances, found that it arose from a misunderstanding of our constitutional requirements. I desire particularly to draw the attention of Subordinate Lodges to this matter, that they should in all cases follow strictly the letter and spirit of our Constitution.

March 1st, a communication was received from St. John Lodge, No. 27, asking how to proceed in the following case: A member of the Lodge some years ago had removed to the United States. He became in arrears for dues, and under Sec. 27 (page 35), Private Lodges, was by vote of the Lodge considered as having withdrawn. Now he wishes to heal his Masonic offence and obtain a demit. How can he do so? I desire particularly to call the attention of Grand Lodge to cases of this kind. There seems to be no constitutional way in which a Brother placed in this position can regain his Masonic standing. He has committed no greater Masonic offence than a Brother suspended for non-payment of dues, and yet the latter can of his own motion regain his standing without reference to any vote of the Lodge. It appeared to me that the only course to be followed was for the Brother to apply as a joining member, and subject himself to a ballot, and I so advised. I think it would be well for Grand Lodge to consider the advisability of enacting legislation to meet such cases.

I regret that, owing to my absence from the Province, and to the calls of my professional work, I have been able to visit but few of our Subordinate Lodges.

On the 1st October, 1889, I visited St. John's Lodge, No. 2, and witnessed the conferring of the E. A. Degree. The work was highly creditable to the Worshipful Master and his officers.

October 8th, I visited Hibernia Lodge, No. 3. In the absence of the Worshipful Master, Past Master R. Clerke occupied the chair, and gave a good exemplification of the work of the First Degree.

October 10th, I visited New Brunswick Lodge, No. 22. The work of the Third Degree was very ably rendered by W. M. Buchanan and his officers.

November 7th, I visited Carleton Union Lodge. Here they had a fine gathering of the Craft, and we were accorded one of those hearty and generous welcomes for which this Lodge has ever been noted.

November 21st, I visited The Union Lodge of Portland. In the unavoidable absence of the Worshipful Master, that veteran and enthusiastic Mason, R. W. Bro. Duffell occupied the chair. Need I say that the work (Third Degree) was just what we should expect from so experienced and zealous a Craftsman as he.

December 16th, I visited Sussex Lodge, No. 7, W. Bro. P. G. MacFarlane, W. M. Here we met with a most cordial welcome. The Communication was well attended, representative Masons from the surrounding districts, as well as some from the neighboring State, being present, including our representative at the Grand Lodge of Maine, Bro. D. F. Seymour. The work exemplified was that of the M. M. Degree. In general effect the work was excellent, though somewhat marred by inaccuracies. The condition of this Lodge is excellent; its members are enthusiastic and its finances healthy.

December 27th, St. John's Day, I visited Albion Lodge and installed the Worshipful Master.

April 2nd, I visited Zion Lodge, No. 21, W. Bro. Geo. Coggou, W. M. We received a hearty welcome from the Brethren of this Lodge, witnessed the work of the E. A. Degree, and were afterwards most generously entertained. I must congratulate the officers of Zion Lodge upon the excellent rendition of the ritual, which was highly creditable to all concerned.

In these visits I was accompanied by a staff of Grand Lodge Officers and Acting Officers, to whom I desire to return my sincere thanks.

A commission has been forwarded to W. Bro. Charles De Boos, to represent this Grand Lodge near the United Grand Lodge of New South Wales. Also a commission to R. W. Bro. J. A. C. Anderson, to represent this Grand Lodge near the Grand Lodge of Canada, in place of V. W. Bro. T. B. Pardee, deceased.

W. Bro. Robert J. Jamieson, a Past Master of Celtic Lodge, No. 291, has been commissioned to represent this Grand Lodge near the Grand Lodge of Scotland, in place of W. Bro. James Webster, deceased.

W. Bro. William Downie has been appointed to represent this Grand Lodge near the Grand Lodge of British Columbia, in place of R. W. Bro. C. M. Chambers, deceased.

R. W. Bro. Robert Marshall having notified me that he would positively decline re-appointment as representative of the Grand Lodge of Iowa, his term of office under their regulations having expired, I directed the Grand Secretary to forward the name of R. W. Bro. G. F. Pinder to fill the vacancy. R. W. Bro. Marshall has so long and so ably filled the office of representative of the Grand Lodge of Iowa, that I much regretted his decision in this matter.

I instructed the Grand Secretary to forward the name of W. Bro. F. W. Wisdom as representative of the United Grand Lodge of New South Wales, a vacancy having occurred owing to the removal of Bro. E. L. Wetmore beyond our jurisdiction.

A report of the dispensations issued will be furnished by the Grand Secretary. I need not enumerate them here.

The W. M. of Lebanon Lodge applied (Feb. 6) for a dispensation to elect and install the officers of that Lodge on the same night, they having neglected to elect them at the constitutional time. I refused to accede to this request: 1st, because no reason was given for their delay in the election; 2nd, because a dispensation to elect and install at the same meeting would be in direct contravention of that portion of Sec. 2, Private Lodges, which reads: "At the next regular meeting following his election, after the minutes shall have been read and approved, he shall be installed according to ancient usage." The officers of the Lodge for the past year must therefore continue in office for the ensuing year.

I have approved a change in the Bye-Laws of Lodge St. Andrew, No. 16, increasing their dues from twelve and one-half to twenty cents per month.

From the M. W. Grand Master of Connecticut I received a courteous invitation to attend the celebration of their Centennial.

From the Grand Master of the Grand Lodge of Illinois I received a kind invitation to participate in the celebration of the Semi-Centennial of that Grand Lodge. I much regret that it was impossible for me to accept either of these invitations, as the proceedings on both occasions were of great interest.

At the request of the Board of General Purposes, the work of the First and Third Degrees will be exemplified at this meeting of Grand Lodge.

This evening at half-past seven the E. A. Degree. To-morrow evening at eight the M. M. Degree. The Worshipful Master of The

Union Lodge of Portland, No. 10, has kindly called Emergency Communications of his Lodge for that purpose.

In conclusion allow me to hope that my earnest desire to advance the well being of our noble order may counterbalance my many shortcomings. For the uniformly kind and courteous treatment I have received at the hands of the Craft, I desire to return my warmest acknowledgments.

Of this amount \$2,205.20 has been paid to the V. W. the Grand Treasurer, and \$117 special subscription paid to the Secretary-Treasurer of the Masonic Hall Company, and a detailed statement furnished the Audit Committee of the Board of General Purposes.

2. I have received the returns of all the Lodges, with the exception of two, and payments have been made in full from returns received, with the exception of two.

Total membership, December 27th, 1889, 1,885, thus showing an increase in membership of five, as compared with the returns of the previous year.

3. During the past year I have issued, by authority of M. W. the Grand Master, fifteen dispensations for the undermentioned purposes:

To confer degrees at short intervals.....	8
To wear regalia in public.....	4
To bury deceased brethren.....	3

Seventy-nine Certificates in parchment have been issued upon special and the regular annual returns, to brethren entitled to them under the Constitution.

4. I received on the 13th May, from Keith Lodge, No. 23, notice of the completion of their new hall, in the City Building, Main Street, and that their meetings would be held in this hall until further notice.

5. A communication was received from the Grand Lodge of Connecticut, announcing that they intended celebrating the anniversary of its independence on the 10th day of July, A. D. 1889.

Invitations were received from the Grand Lodge of Illinois to be present at the Semi-Centennial Anniversary of the organization of that Grand Lodge, commencing on the first day of October, 1889. Three bound copies of their proceedings for 1889, including the Semi-Centennial communication, were received; one for the Grand Lodge, one for the Grand Master, and one for their Grand Representative. Also a bronze medal for Grand Lodge, in commemoration of the above event.

6. On the 14th June a communication was received from the United Grand Lodge of Victoria, dated Melbourne, 22nd April, 1889, announcing that on the 25th March this Grand Lodge was inaugurated and duly constituted; with a request for official and fraternal recognition by the Grand Lodge of New Brunswick.

The Grand Lodge of North Dakota, organized on the 13th June, A. D. 1889, and recognized by the Grand Lodge of Dakota, respectfully request fraternal recognition by the Grand Lodge of New Brunswick.

A circular and copy of proceedings were received from the Grand Lodge of the Republic of Peru, asking for recognition as a Grand Lodge.

These papers were placed in the hands of the Committee on Relations with Foreign Grand Lodges.

7. October 23rd. Official notice was received from the Grand Lodge of Quebec of the withdrawal of Proclamation and Edict of Non-intercourse with the Grand Lodge of England and all Lodges and Brethren in obedience thereto.

8. On the 16th September, a communication was received from the Grand Secretary of Scotland, advising us of the death of our Grand Representative, W. Bro. James Webster.

And on the 23rd March, 1890, notice was received from the Grand Secretary of British Columbia of the death of our Representative near that Grand Lodge, W. Bro. C. M. Chambers.

9. A beautiful bronze medal was received from M. W. Bro. Frank R. Lawrence, Grand Master of the Grand Lodge of New York, in commemoration of the freedom of the Craft from debt in their jurisdiction, A. D. 1889.

10. Commissions have been received accrediting the following named Brethren as Representatives of their respective Grand Lodges near the Grand Lodge of New Brunswick, viz.:

W. Bro. J. Henry Leonard, P. M. of Carleton Union Lodge, No. 8, as Representative of the Grand Lodge of Illinois. R. W. Bro. George F. Pinder, P. M. of Sussex Lodge, No. 7, as Representative of the Grand Lodge of Iowa. W. Bro. Freeman W. Wisdom, P. M. of Albion Lodge, No. 1, as Representative of the United Grand Lodge of New South Wales.

These commissions have been forwarded to each of the Grand Representatives, who will no doubt present them to Grand Lodge in due course.

11. Commissions have been issued under the Seal of Grand Lodge to R. W. Bro. J. A. C. Anderson as Representative of this Grand Lodge near the Grand Lodge of Canada; to W. Bro. Robert J. Jameison, P. M., as Representative of this Grand Lodge near the Grand Lodge of Scotland; and to W. Bro. William Downie, as Representative of this Grand Lodge near the Grand Lodge of British Columbia.

## Report of the Board of General Purposes.

THE R. W. the Deputy Grand Master, as President of the Board of General Purposes, submitted the Annual Report, as follows:

SAINT JOHN, N. B., April 22nd, 1890.

To the Grand Lodge of Free and Accepted Masons of New Brunswick:

The Board of General Purposes herewith submit their annual report.

At the first meeting held on the 9th day of May, 1889, W. Bro. W. Watson Allen was elected Vice-President.

It was resolved that the meetings of the Board be held quarterly on the first Wednesday in August, November, February, and April, at four o'clock in the afternoon.

On consideration of the report of District Deputy Grand Master, Lovet M. Wood, the Board affirms that it is not advisable to enter upon the consideration of the question of providing travelling expenses for the District Deputy Grand Masters.

In reference to that part of the Grand Master's address relating to a special collection towards the floating debt, the Grand Secretary was instructed to issue a circular to the different Lodges, asking for contributions; only four (4) responded, viz.: Woodstock, No. 11, \$50.00; Zion, No. 21, \$13.00; New Brunswick, No. 22, \$10.00; and Albion, No. 1, \$44.00.

The Ritual Committee were requested to exemplify the work at the meeting of Grand Lodge, which they have consented to do, and which it is hoped will be of benefit to the Brethren within the jurisdiction.

The Deputy Grand Master reported that he had visited Howard Lodge, No. 15, at Hillsboro, and while there the Secretary, by advancing part of the amount, paid the Grand Lodge dues for 1888, and requested that the Grand Lodge dues for 1889 be remitted, as the Lodge was in very straitened circumstances; whereupon it was unanimously resolved that the Board recommend to Grand Lodge that the prayer of Howard Lodge be complied with, and that the dues for 1889 be remitted.

With reference to the proposed change in the meeting of Grand Lodge, all the Lodges in the jurisdiction have been communicated with in regard to this matter. It is the opinion of the Board, from information received, that it is not advisable to change the date of the Annual Communication.

A Committee was appointed to audit the books and accounts of the Grand Secretary and Treasurer. Having attended to that duty they reported as follows :

During the past year I have been unable to make many visits, business and other circumstances preventing me.

M. W. Grand Master, Officers and Brethren of Grand Lodge:

M. W. SIR AND BROTHERS:

I beg leave to report that during the year I have visited all the Lodges in the District with the exception of Salisbury, and was very cordially received at each place.

On December 27th I visited Keith Lodge, No. 23, at Moncton and installed the officers-elect. This Lodge is in a very prosperous condition, having visited it several times since. I am pleased to say that increased interest is manifested and new members are applying at each meeting. On Sept. 4th I was called upon to officiate at the funeral of our esteemed Brother John S. Trites, an old and respected member; also on April the 8th, to attend the funeral of Worshipful Bro. Judge Bliss Botsford, Past Master, who for years was an earnest worker in Craft Masonry, and was the oldest Past Master of Keith Lodge.

On January 8th, accompanied by W. Bro. H. A. White, of Zion Lodge of Sussex, and W. Bro. H. B. Fleming, of Keith Lodge, I visited Zetland Lodge, of Shediac, and installed the officers. The Lodge is in a prosperous condition.

On February 4th I visited Albert Lodge, and was pleased to find that they were occupying their new hall, which is centrally situated. The attendance was good. Books kept nicely, and \$180 to their credit in the bank.

On February 5th I visited Howard Lodge. The field is small at this place, and the Brethren deserve credit for keeping the Lodge in the condition it is. They have a nice hall, and well furnished. In 1888 they elected Brother Stewart to the chair, but he could not be induced to come forward to be installed, so they were without a Master during the year, and had no meetings until December, 1889, when they elected W. Bro. Osman to the East. The night I met with them we worked the Entered Apprentice Degree. They paid me the Grand Lodge dues for 1888, and said if the dues for 1889 were remitted by Grand Lodge they had every hope of successfully carrying on the Lodge. The books were very neatly kept.

February 10th I visited Lebanon Lodge, of Sackville. During the year the W. Master moved to the United States, and they had but few meetings. I placed the Lodge in charge of Past Master H. Phinney,

who has carried it on so successfully in the past. We worked the M. M. Degree upon a candidate who had been away for some time. An application was received. They have about \$60 in the bank, with reasonable prospects of future success.

On March 6th I visited Sussex Lodge, of Dorchester. I am pleased to report the continued success of this Lodge. We worked the M. M. Degree, and received an application for membership. They do not now sub-let their hall, and have quite a large sum of money on hand. Everything is in good order and books well kept.

I tried on several occasions to arrange a meeting at Salisbury Lodge, but failed. The W. Master lives at Point de Bute, and there are no resident Masons who will take any interest in the work or attend the meetings. They have not had a meeting for over a year. The best I could do was to get them to pay the Grand Lodge dues for 1888. I have been agitating the removal of this Lodge to Petitcodiac, where a good field is open for it, and I think it can be accomplished in a short time.

I had the pleasure of attending a meeting of Zion Lodge, at Sussex, on April 2nd, accompanying the Grand Master. I have no hesitation in saying that it is the best working Lodge outside the City of St. John that I have visited.
