REPORT FROM THE COMMITTEE ON YOUTH

To the Right Worshipful Brother William Boone, Deputy Grand Master, Officers and members of the Grand Lodge of New Brunswick F&AM

It is with great pleasure I submit the following report on the activities of our youth in this and the surrounding grand jurisdictions.

I have some good news and some bad news. First the bad news: R.W. Bro Maurice Linkletter has retired as the EO for Atlantic Canada DeMolay. For those of you who know RWB Linkletter, you can appreciate this was a difficult decision for him to make. Of all the advisors I have ever met, he has been and continues to be, one of the most dedicated volunteers to the Order of DeMolay. His career has not ended, simply moved. He has relocated to Ontario, and our loss is their gain. And now for the good news: I was appointed to the position of the Executive Officer for the Atlantic Provinces DeMolay. You can understand that I have some pretty big shoes to fill, but being a clown has some advantages and, I feel I might just be able to step up with my size 18's.

Young new members are the future of our organizations and DeMolay and Rainbow are great places to start. They are our future, and what better kind of a future to have; a future with new members who understand the fundamental principles of the Masonic Fraternity, and who have been trained in Ritual, Public Speaking, and Leadership skills.

I heard a senior member of our Fraternity recently say to a group of new masons, some still Entered Apprentices and Fellow Crafts, that they were the future of our Fraternity. One of the new members was involved with Boy Scouts throughout his life and will become part of my staff because of the greatness he sees in the organization of DeMolay. Another asked about DeMolay during his second mentor session after completing his first degree and now has two of his three sons now involved in the organization and they

Yet another was so impressed with the ritual work presented by the local DeMolay Chapter when his son was initiated into DeMolay, he immediately wanted to know about joining the fraternity. Having recently become a Senior DeMolay he wanted to further his Masonic education by becoming a Mason like the advisors that cared enough to volunteer their time to work with him as a boy. There are countless other examples right in your own back yard, leaders in our fraternity, men who without DeMolay, might never have petitioned to join our ranks.

The members of DeMolay are active in Moncton, Fredericton, St. Stephen, and Halifax. The boys have helped out with several charitable organization fundraisers this year, and continue to support the Scottish Rite Learning Center project. This coming summer, DeMolay will be holding it's fourth annual convention hosting members and advisors from New Brunswick, Nova Scotia, and Maine. Your contributions to the program ad's help make the event a success. This year there will be a special awards program as part of the Saturday evening banquet and ceremonies. I encourage all of you to attend and show your support for the advisors and members of the Organization.

On the girls side of the coin, the International Order of Rainbow for Girls has had a truly eventful year. Codiac Assembly #25 was very happy to participate in the initiation of 5 new girls from Nova Scotia. Once they have a total of 12 girls they will be a part of a new Assembly in Nova Scotia. Along with the initiations in Nova Scotia, the Codiac Girls have had a great time volunteering their time to help out the Walk for Muscular Sclerosis and getting their hair trimmed to help out the Scottish Rite's fundraising for their Learning Center for Dyslexia. In August, they will be travelling to Toronto, to again attend their Annual Grand Assembly of Canada Sessions.

As always we continue to look for new members, new advisors, and new frontiers. We continue to struggle with the rising costs of insurance, and the necessities of adult background checks to ensure the safety of our youth. We continue to be thankful for the support shown to us by all the concordant bodies of the Masonic Fraternity, but I would like to especially thank the Masons. The Masons that make DeMolay and Rainbow the great organizations they are; the Masons that volunteer countless hours of their time to help; the Masons who attend a meeting or installation of officers; the Masons who work at a fundraiser to help pay for the cost of insurance; the Masons who simply buy a ticket to a pancake breakfast. Your support is essential to the survival of our youth groups.

Each year, we as Masons unite as brethren and raise countless dollars for Camp Goodtime and other charities. We unite as brethren and bring new members into our lodges. Let's continue to unite as brethren and do what ever we can to ensure the future of our organization and society as a whole. Our youth are our future. Be a part in moulding that future and take pride in our youth. To use parts of a phrase from my own lodge notice "DeMolay has

a heritage in our region and in our fraternity. Yours is both a privilege to treasure and a responsibility to uphold."

GRAND HISTORIAN'S REPORT

Rt Wor Bro Boone, DGM, with permission I herewith submit my Grand Historian's report for the 2007 Annual Grand Lodge Communication.

The most dramatic event since the Grand Lodge communication of 2006 has been the unexpected and untimely death on 11 January 2007 of our Grand Master the late M Wor Bro Wayne H Mckay. The Masonic service with 400 hundred or more brethren paying their respects and the funeral service the next day with 80 or more Masons in attendance, I believe indicate the respect and sorrow of the fraternity with his loss.

I believe the last time the death of a GM occurred during his term was in 1981, when M Wor Bro Clarence Carter passed away unexpectedly and Rt Wor Bro Coffey as DGM assumed the role until the time of election of a new GM at the 1981 Communication of Grand Lodge.

Another incident to be considered was the retirement of M Wor Bro Ralph Andrews from the office of Grand Secretary in 2006. M Wor Bro Andrews was first appointed Grand Secretary in 1992 with his retirement in 2006 he had completed fourteen years in that office. He held the office of DGM in 1991, before surrendering any further advancement to accept the office of Grand Secretary.

The surrender of the warrant of Centennial Lodge No 53 in July of 2006 should also be considered as a moment of historical importance. At any time a lodge finds they must relinquish their position within a Grand Lodge is a moment of reflection and review. Those members of lodges who are still in light must step back and consider what their particular lodge is offering to the members and determine if it is enough. It would appear that the main factor affecting lodges, which cause them to surrender to the forces of darkness, may well be apathy and a general unwillingness to reconsider what the lodge is actually offering in way of encouragement and fellowship. Members of Centennial Lodge have sought affiliation with Alexandria Lodge and Hiram Lodge of Fredericton.

During the 2006 year Sussex Lodge No 7 of St Stephen commemorated 160 years as a Masonic Lodge, (1846-2006). The presiding Master Rt Wor Bro Don Jones conducted a Lodge of Sorrow to recognize the departed brethren of those 160 years. It is assumed that Sussex Lodge No 7 and

Sussex Lodge No 4 of Dorchester (1840 UD and warranted 1842) were most probably named after the Duke of Sussex.

It might be said that Sussex Lodge No 7 of St Stephen was a descendent of Orphan's Friend Lodge No 34 of a warrant from the Provincial Grand Lodge of Nova Scotia, though Orphan's Friend was only active from 1809 to 1823.

Sussex Lodge No 7 has given four GM to this Grand Lodge, Julius T. Whitlock, (1895-1896); John S D Chipman (1907-1908); James Vroom (1926-1927); Gordon W Coffey (1983-1984).

To the time of the 2006 election of Grand Masters there have been sixty-four brothers who have occupied Solomon's Chair in the Grand Lodge East. Rt Wor Bro Thomas Walker, MD served as Grand Master for eight terms. Using the term Rt Wor Bro for Past Grand Master Walker is not a mistake it was not until the Grand Lodge Communication of 1964 that the honorific rank of M Wor Bro was accorded Past Grand Masters.

Past GM Walker's record is exceptional as was J Twinning Hart who served as Grand Secretary for 39 years, (1897-1936); William F Bunting Grand Secretary for 14 years, (1867-1881).

The record of Bro Dingee Scribner who served as Grand Tyler for 30 years; (1879-1900), is in itself remarkable.

I have heard that Bro Scribner, whose first name was his mother's maiden name, died returning from a bird hunt, when his horse bolted and overturned his carriage. Brother Scribner manufactured salmon rods and was a fishing companion of William F. Bunting.

M Wor Bro A. S. Robinson served as Grand Master (1945 -1946), following this post in 1947 to become the Grand Historian for the next 19 years.

Alexandria Lodge honoured Bro Clair MacMillan with a plaque to honour his 40 years service on the Lodge's Audit Committee.

Many of the lodges in the past year have been honouring their long serving members with awards of 60 year pins, 50 year certificates and recognizing those with twenty five years in Freemasonry.

Remembering those brothers who have held their Masonic membership for many years has an importance all of its own. Not to be forgotten are those family ties, such as Westmoreland Lodge reporting three brothers in the East, brothers by blood as well as fraternal brotherhood. Wor Bro Steven

Allen, Worshipful Master; Wor Bro Dale Allen, Immediate Past Master and Bro Roderick Allen, Chaplain.

Unfortunately Granite Lodge's fun-filled Duct Tape Derby was not held during the summer of 2006 and it can be hoped the lodge will not let this fun filled event be forgotten.

Many of the lodges have during the past year in the month of November conducted various memorial services in remembrance of both the Canadian Armed Forces veterans who met the supreme sacrifice in their country's name, but to remember also the brethren who have been admitted to the Celestial Lodge Above. Their memories we cherish in our hearts.

The Roosevelt International Day at Campobello on 06 October 2006 was a perfect example that Freemasonry is not confined to one province or one country but is genuinely international. Though it was obvious the Senior Deacon had a bit of trouble knocking on a non-existent door.

Training within the jurisdiction has not been forgotten, the Grand Lodge Training Team setting up programmes in the different districts. While attendance at these events may not be as great as the teams would like, there is interest and such programmes should continue.

It is obvious that some of the events within the jurisdiction are not noted above and the suggestion is made here that the lodges should be making more use of the Grand Lodge Web site to spread the news of their functions and events so all Masons in the province can share in the occasions that happen

A proposal has been put forth for the creation of a database of the archives and artefacts held by the subordinate lodges of this jurisdiction, with the main concern that the history of this Grand Lodge be recorded for future generations. The record of the archives held by Grand Lodge at the time of the preparation of this report after several years, are close to being completed, for which as Grand Historian I extend my thanks to Wor Bro Stuart MacDonald of Albion Lodge for his sterling efforts.

Each member of the team was allowed to ask the audience for help if required. The topics, ranging in value from 10 points to 50 points with the question difficulty rated according to value, were History, Etiquette, Ritual, Constitution and Grand Lodge. From all reports, the evening proved entertaining as well as educational.

The training team will be conducting the annual DDGM seminar again in 2007, probably in August, the same as 2006. As well, the team is willing to travel to any lodge on request to conduct an educational program. It should be noted that any Worshipful Master, with a little planning, can put on a Masonic Jeopardy or demonstration program at his will and pleasure. The team is also available to put on more advanced training in the area of communication, delegation, planning, conducting a meeting, lodge administration and more. Make your needs known and we will respond accordingly

The Ritual Committee is continuing with the collection of the various versions of these individual lectures/rituals, review them for consistency and publish in a booklet format after approval by the Board. This work is still in progress.

After several meetings we decided to change investment advisors from CIBC Wood Gundy to RBC Asset Management, which was accomplished in March 2007.

GRAND SECRETARY'S REPORT

I thank you for your encouragement and understanding during the year as I went about locating files, records and information that you have requested of this office. Brethren, the task in this office of becoming Grand Secretary has been a formidable one and a great challenge.

Beginning with the closing of Centennial Lodge No 53, there were 72 demits issued. Although some members had already affiliated with other lodges, and still others have since affiliated with nearby lodges, we suspect that there are a number who have not continued their Masonic membership. This office should be able to identify those Masons and direct their names to lodges in District #6 and elsewhere. We should also be able to pass on names of those who live outside this jurisdiction through the Comely Program with the hope that they do not slip away completely.

This year we can report that annual returns have been received from all lodges in the jurisdiction, and most of those lodges have remitted Grand Lodge dues at the time of writing. But while the annual returns have been duly received, the mailing lists of Grand Lodge members among their midst have not been submitted by all lodges, leaving us in the uncomfortable position of not knowing whether all members have received their notification of the Annual Communication, which we are now attending, because our mailing list may not be completely current. This omission denies eligible members the opportunity to attend, and, in addition, becomes an expense to this Grand Lodge.

Also, there is an annual report that we rarely receive, and we call your attention to the need to submit annual financial statements.

In the coming year, we shall attempt to make use of our membership data-base in completing Masonic. "histories" of all Masons who have served as Worshipful Master and as an officer of this Grand Lodge.

In closing, I thank you all for your help throughout the year in assisting me in the execution of my duties, and in particular, I am greatly indebted to R:W:B: Chesley Piercey for his invaluable assistance.

REPORT OF DEPUTY GRAND MASTER

To: The Officers and Members of The Most Worshipful Grand Lodge of New Brunswick

For the third time in our history, the Deputy Grand Master has been called upon to preside over Grand Lodge due to the passing of the Grand Master on January 11, 2007. This report will be a combination of the Grand Master's report - which is understandably not forthcoming - and the Deputy Grand Master's report, covering the activity of both officers.

The unexpected raising of M:W:B: Wayne H. McKay to the Celestial Lodge above, came as a shock to all who knew him. Yet, to quote a portion of the Officer's Installation ceremony, "... the time will come, and the wisest knows not how soon, when all distinction shall cease and death the grand leveller of human greatness shall reduce us to the same state." Greatness is fleeting; goodness everlasting.

His funeral service, which I had the honour to conduct at the request of his Mother Lodge Alexandria #33, saw one of the largest turnouts of brethren in recent memory. Over 400 were present at the Masonic service, and more than 200 attended the Funeral service the next day. Truly an amazing tribute by the Masons of New Brunswick.

And so, on his behalf, and in his memory, with warm fraternal greetings I welcome you to this the 140th communication of the Grand Lodge of New Brunswick. To our honoured guests from other jurisdictions, your presence exemplifies the strong ties that exist within the fraternity and we are delighted you could be with us. To the representatives of the Concordant Bodies, I also extend a hearty welcome. The bond of brotherhood knows no boundaries or limitations, no conditions or restrictions; simply one large family with one common aim: to make good men better. May your visit with us be rewarding, fulfilling, comfortable, and leave you with many pleasant memories.

Let us now pause for a solemn moment of reflection on those brethren who, in addition to our Grand Master, have passed to the Celestial Lodge above during the past year. As we watch the grains of sands pass in the Hour Glass, behold how swiftly the sands of time draw our lives to a close. At the end of Man's short hour, death strikes the final blow and hurries us off the stage to our final reward. We extend to the bereaved families of the departed brethren our heartfelt sympathy in their sorrow. Their memory shall linger when time shall be no longer.

Please rise to observe a moment of silence, following which a prayer will be offered by our Grand Chaplain, V:W:B: Rev. Dana Dean.

Visitations

Although M:W:B: McKay did not pay a visit to every Lodge during his second term, he was well on his way to that goal when that term was cut short. While the visits he did make were termed "official", he saw them more as an opportunity to meet with the brethren, exchange ideas, and strengthen the fraternity. He was a man to embrace new ideas, to look beyond the norm and try new things. Such innovations did not always sit well with some, but he never lost his ability to give a measured and thoughtful response.

It was my honour and privilege to accompany him on most of these visitations within the jurisdiction. While I do not have exact numbers for the Grand Master, my own will provide some indication of his travels. During the past year, I travelled in excess of 30,000 kms, attended upwards of 90 Masonic functions, as well as maintaining the official Grand Lodge website, and helped conduct several educational and training seminars. This interaction with Masons in New Brunswick, and beyond, has been most rewarding.

The Grand Master, along with myself and officers of Grand Lodge, had the distasteful chore of overseeing the closure of Centennial Lodge, Oromocto, in July of 2006. The membership of largely military personnel being more transient in these troublesome days often left the Lodge with insufficient numbers to fill the offices. The building and assets became the property of Grand Lodge, which was able to dispose of them in a timely fashion for a reasonable return. The Charter is now in the Grand Lodge Archives.

On a more pleasant note, a re-dedication of Lodge St Andrews, Rexton, took place on September 11, 2006 with the Grand Master and officers of Grand Lodge in attendance.

M:W:B: McKay represented the Grand Lodge of New Brunswick at the communications of the following Grand Lodges:

He also had made arrangements to attend the North American Conference of Grand Masters in Oregon in February, 2007 where he was to

chair the time and place committee. He was also named co-chair of the All Canada Conference held in Winnipeg, Manitoba, March 29-30, 2007.

In addition, M:W:B: McKay, with the assistance of Grand Lodge officers, conferred the MM Degree on Brother Gary Cook, Sunset Lodge No 56, at an outdoor Lodge in Roosevelt Park with the Grand Lodge of Maine in attendance. He was also a special guest at International Day co-hosted by Colebrooke Lodge No 39 and Pioneer Lodge, Ashland, Maine, held in Grand

That, to the best of my recollection and notes, covers the highlights of the Grand Master's second term of office.

We turn now to the events following January 11, 2007, with me as Deputy Grand Master assuming the duties and responsibilities of the Grand Master. There appeared to be some confusion at first among the brethren as to title and rank. I was addressed as everything from R:W: the Grand Master, to M:W: the Deputy Grand Master. Eventually it became clear I was still the Deputy Grand Master; all I had taken on were extra duties without the bells and whistles.

On the day of his passing, the Grand Master had been scheduled to do the installation of officers at Zetland Lodge, as well as at Corinthian Lodge two days later. In the first instance, the event was postponed until January 30 at which time I carried out the ceremony. Corinthian Lodge decided to carry on with their installation with a last minute replacement.

With the immediate commitments looked after, it was necessary to schedule the annual District meetings to be held throughout March and April. The number of brethren who turned out to accompany me on these official visits proved most gratifying because it indicated the unity that exists within the Craft regardless of the adjustments that need to be made in the wake, of tragedy. Even the absence of an apron on a principle officer on one official visit did nothing to dampen the enthusiasm; in fact, it lightened the mood considerably.

As mentioned, I, along with the Grand Secretary, R:W:B: James McKenna, attended the All Canada Conference in Winnipeg March 30-31, 2007. I was honoured to be asked by the Chairman, M:W:B: Gary Atkinson, Grand Master of Canada in the Province of Ontario to sit as vice-chairman. R:W:B: Dan Campbell, Deputy Grand Master of Nova Scotia, suggested we in the Atlantic Provinces look to reviving the Atlantic Conference dormant for the past few years. Further discussion on this will take place later this year. Jurisprudence

Three items were being held in abeyance pending the appointment of a Jurisprudence Committee, which the Grand Master had put off for reasons

unknown. Finally, in February, 2007, R:W:B: Miles Graham, S:G:W:, R:W:B: Evan Thomas, P:D:G:M:, along with chairman, W:B: Scott Ellsworth were appointed to this committee. They were immediately assigned the pending questions of:

1. On a complaint to the Board of General Purposes that M:W:B: Wayne McKay had violated the constitution by not introducing his suite of officers according to the order of recognition contained therein.

> In the committee's opinion there was no violation because the section on recognition makes no mention of the order of introduction.

- 2. On referral of a motion by the Board of General Purposes to amend the Board of Trial section of the Constitution, the Committee has completed a rough draft. The final form will be completed later this
- 3. The matter of expulsion or suspension for any brother convicted of a criminal offence in a court of competent jurisdiction is being considered. At the moment there are no provisions directed toward this specific violation of Masonic conduct. While the matter is being studied by the Jurisprudence Committee, it is obvious that the need for a trial is necessary even though a certified copy of the conviction may be introduced as prima facie evidence of unmasonic conduct.

Further information will be available in the Jurisprudence Committee Report.

District Deputy Grand Masters

Five of the seven District Deputy Grand Masters are finishing their twoyear term while the other two have one more year. I would be remiss if I failed to express the heart-felt appreciation the late Grand Master, M:W:B: McKay had for his dedicated team of DDGMs who carried out their duties with zeal and commitment. I can only echo his sentiments. Their support over the past four months played a large part in the successful continuation of the business of Grand Lodge, thank you brethren, your successors will have large shoes to fill.

State of the Craft

Overall, the state of the craft has many positive aspects. All lodges have enjoyed initiating new candidates, some in double figures. Most, if not all, have held fundraisers to support Camp Goodtime with three lodges in the Moncton area combining to raise \$12,000. A remarkable achievement.

JUNE

There seems to be a renewed interest in Masonry from younger men judging from the inquiries being made via the website as well as to individual Masons from around the jurisdiction. These potential candidates have done their homework and probably have more background knowledge of the fraternity than many of our regular members. For the benefit of those who apply and are accepted, it places a great responsibility on the officers of the lodge to know their work as well as to perform the ritual beyond reproach, to far exceed the expectations of the candidate. The late Grand Master expressed his concern on different occasions about what he considered a decline in ritual performance at Funeral Services and during degree work. Funeral services in particular have a large impact on non-Masons. A high standard of performance will ensure we are seen at our best in such setting.

And so, my Brethren, it has been my objective to carry out the commitments made by our late Grand Master, and to steer the ship of Masonry to the port of Grand Lodge where you will select a new Captain. With your help and support, it has been fair sailing.

Let me leave you with this thought from nearly 200 years ago, but just as applicable today:

Union and harmony constitute the essence of Freemasonry; while we enlist under that banner, the society must flourish and private animosities give place to peace and good fellowship. Uniting in one design let it be our aim to be happy ourselves, and contribute to the happiness of others. Let us mark our superiority and distinction amongst men, by the sincerity of our profession as Masons, let us cultivate the moral virtues and improve in all that is good and amiable; let the Genius of Masonry preside over our conduct, and under her sway let us perform our part with becoming dignity, let us preserve an elevation of understanding, a politeness of manner, and an evenness of temper; let our recreations be innocent, and pursued with moderation; and never let irregular indulgences lead to the subversion of our system, by impairing our faculties, or exposing our character to derision. In conformity to our precepts, as patterns worthy of imitation, let the respectability of our character be supported by the regularity of our conduct, and the uniformity of our deportment, then, as citizens of the world, and friends in every clime, we shall be living examples of virtue and benevolence, equally zealous to merit, as to obtain universal approbation.

It is with great pleasure that I present the Annual Report of the Masonic Charities & Housing Company Ltd. for the year 2006-2007.

At Grand Lodge in May 2006 Betty Hoyt, Director of Community Programs, N.B. Division of The Canadian Cancer Society was presented and accepted a Cheque in the amount of \$36,088.00 to support Camp Goodtime and the Junior Leadership Program for 2006.

Fund Raising:

Masons of New Brunswick again in 2006-2007 have shown their dedication and passion by providing in excess Of \$35,000.00 to fund our projects. The fund raising activities by the blue lodges and concordant bodies are providing great public relations at the local level involving many communities in New Brunswick. Total funds raised for the year 2006-2007 are in excess Of \$42,000.00 dollars from our blue lodges, concordant bodies of Masonry, Individuals and corporate donations.

The term " Camp Goodtime", is well known in New Brunswick today.

N.B. Masons Camp Goodtime:

In July Of 2006 thirty-one (31) campers ages 7-12 (original Camp Goodtime) and twenty-seven (27) campers ages 13-16 in the Junior Leadership Program (JLP) attended an eight (8) day summer camp for children with a history of cancer for a grand total of fifty-eight (58) kids (The largest Camp Goodtime to date). Junior Leadership Program was again a great success and the combined camp will continue in2007.

Board of Directors:



REPORT OF THE BOARD OF GENERAL PURPOSES

The report of the Board of General Purposes was presented by the Vicechairman, R:W:B: Miles Graham.

To: The Officers and Members of The Grand Lodge of New Brunswick.

The Board of General Purposes held four meetings since the last communication of this Grand Lodge in May:

1. June 24, 2006:

- a. This session, for the most part, dealt with administrative issues in the form of final reports from committees, putting in place the President of the Board, RW William Boone, DGM and Vice President, RW Miles Graham, SGW.
- b. RW Bill Ryan reported that arrangements for Grand Lodge 2006 came in under budget, and with the exception of a shortage of kitchen staff for the Saturday night banquet, all went well. The unexpected shortage of staff was overcome by the timely intervention of R:W:B: Doug Mayes and other brethren who did a superb job on short notice. The Board extends sincere appreciation for their effort.
- c. A short review of the events surrounding the recent Masonic trial revealed that some procedures need to be clarified. It was

- suggested the process be reviewed by the Jurisprudence committee.
- d. The issue of any brother being convicted of a serious offence in the Judicial Court system was raised as a concern, and it too is to be reviewed by the Jurisprudence Committee.

Recommendations for ratification: None

2. November 6, 2006:

- a. Moment of silence for departed Brother RW Basil Prescott, Past Grand Secretary.
- b. Reports from the DDGM's concerning Freemason Day held on September 16, 2006 indicate a mix of highly successful to not successful at all. Many useful suggestions were offered for a more successful event in the future, including coordination on the district level. Indications are it should continue.
- c. The Board was given a verbal report by the Grand Master regarding the closing of Centennial Lodge in July 2006 and the disposal of its assets. The furnishings were donated to various Lodges, the records returned to the Grand Secretary's Office for sorting and storage in the Archives, and the property sold. Monies realized go to Grand Lodge.
- d. Several Committees reported progress.
 - i. Bursary: Nine (9) paid and one pending
 - ii. Awards: Reminders of deadlines and requirements
 - iii. Constitution: Editing is in progress and will be ready for presentation at Grand Lodge 2007
 - iv. Youth: Overview of work with DeMolay and need administrative funds
 - v. Ritual: No contentious issues; investigating ways and means for better interaction with lodges and similar committees.
 - vi. Foreign Relations: Recommendations for recognition and representatives for several sister jurisdiction ready for Grand Master's perusal.
- e. 2006 Grand Lodge proceedings ready for printer.
- f. The Grand Historian gave a report on the need to develop an Archives Data Base to accurately record and maintain historical items for the Archives. To be pursued at greater depth.
- g. In his closing remarks the Grand Master made it quite clear he wished to see the practice of giving grace before meals or lunches being observed on a regular basis. He also expressed concern that some funeral services were not up to our usual standard, reminding the brethren our performance is on display for the public.

Recommendations for ratification: None

February 3, 2007

- a. A moment of silence for departed MW Wayne McKay, Grand Master.
- b. W:B: Graham Fraser welcomed to the Board in the capacity of organizer for Grand Lodge 2007.
- c. On the matter of the Archives Data Base held over from February 2007, it was duly moved and seconded that a recommendation be made to the new Grand Master that a Grand Lodge Archives Committee be appointed with the Grand Historian as chairman. Carried. To be ratified.
- d. The Foreign Relations Committee reported that a number of representatives to other Jurisdictions have been made, and others are
- e. The Board reviewed a proposal by MW Wayne Hitchcock, PGM, to allow the presentation of "The Rusty Nail" (degree) to Lodges requesting the same. After further scrutiny the Ritual Committee gave their okay to proceed. Basically, the presentation is a recap of the three degrees specifically aimed at brethren who have been absent from Lodge for an extended time. To be ratified.
- f. The Board received a letter from Howard Lodge No. 15 expressing their concern over the order of introduction of Grand Lodge officers during an official visit; that it did not conform to the order of rank and recognition as outlined in the Constitution. In forming the line up, and subsequent introductions in descending order, MW McKay first introduced the elected and appointed Grand Lodge officers then the Past Grand Officers. Howard Lodge felt he had violated the Constitution by not following the established order by rank and title. Although the issue was moot due to the passing of the Grand Master, a motion was passed that the order of line up and introduction by the Grand Master be according to rank as outlined in the Constitution. The Deputy Grand Master remarked that he had no problem with the request and intended to follow the earlier method of introduction anyway. However, it should be noted the Jurisprudence Committee at the March meeting gave the opinion the Constitution made no reference to "introduction" therefore, the Grand Master had the right to introduce his officers as he saw fit. In addition, as the Grand Master is charged with enforcing obedience to the Constitution, it therefore follows that he is the one who makes the determination on any interpretation or application of the law. Only Grand Lodge in general assembly can over-rule him. On this basis, the Grand Master felt he had the right to introduce his officers as he did without contravening the Constitution.
- g. It was noted that there are deficiencies in the Board of Trial regulations. The matter referred to the Jurisprudence Committee for a report at the March meeting.
- h. On a motion passed, the Board will acquire a framed portrait of the late Grand Master, MW Wayne Mckay, for presentation to his widow, Karen McKay, at Grand Lodge, May 2007.


