### **REPORT OF THE FINANCE COMMITTEE**

To: The Most Worshipful The Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

The financial results of Grand Lodge continue to yield a planned surplus of revenue over expense as a result of our maintaining expenses within budget for the year ending December 31, 2013. Once again expenses have been funded entirely from our annual assessments and our investment income has been retained within our investment portfolio. The year over year assessment revenue was down slightly as a result of the continued decline in our membership numbers and we are forecasting a further decline in the 2014 numbers. With that forecast in mind we have struck a somewhat liberal expense budget however we are confident that we will produce another small surplus through prudent spending in the coming months.

Our balance sheet shows a good year over year increase in our investment portfolio as we continue to benefit from a robust investment environment and again have reinvested the full proceeds our investment income back into the portfolio. We will continue to follow a conservative investment approach as we receive sound guidance from our portfolio managers.

While our 2014 budget represents the second year since our last assessment increase we should all be mindful that we must at least maintain our current membership numbers not only for the financial health of our operations but also for the continued well being of the Craft itself.

Thank you to our Treasurer, Bob Keirstead, for his continued good stewardship in maintaining our records. Also thank you to the other members of the Finance Committee, Randall Nelson and Gordon Thorne and our auditors who collectively have provided a very solid Finance Committee for The Grand Lodge of New Brunswick.

W ith the Deputy Grand Master, R:W:B: Clyde M. Townes in the East, the Grand Master, M:W:B: Stephen H. Allen, gave the following Address.

## **REPORT OF THE GRAND MASTER**

To the MWs, RWs, VWs, Ws, Distinguishing Visiting Guests, and Brethren all:

It gives me great pleasure to present to you my report as Grand Master of the Ancient and Honourable Fraternity of Free and Accepted Masons of New Brunswick at our 147th annual communication of our Grand Lodge.

As I look back and reflect upon my first year as Grand Master I have to say that I cannot believe that a full 12 months has passed by so quickly. It seems like only a few short days ago that I was installed into the position of Grand Master of this great Fraternity of ours, which I might add at this time my heartful and sincere thank you to MWB Myles Graham and his team for performing that task last year and has accepted and is poised to perform that same duty this year. Thank you MW.

We were however saddened deeply with the passing of one of our very respected and valued members of our Fraternity, MWB James Pike. His passing was a great loss to us all, both at a Grand Lodge level and locally to Districts 2 and 7. His ever present attendance to both Lodge meetings and various other functions

and bodies will be missed. He will also be forever remembered for his attention paid to a 10 pm closing of our Lodge meetings. I would also like to commend WM Sean Simpson and his team with the handling of the memorial service and the respect and attendance of the PGMs and representation from the Brethren throughout the whole province and beyond; so very fitting and respectful for such a valued and respected member of our Fraternity. He will be sadly missed by all.

As I sat down to prepare my report I thought that it hardly seems adequate the words "Thank You" to express my gratitude for all of the assistance, support, privileges and participation that has been extended to me in every aspect of this job I have attempted to perform in this past year and Brethren let me say. This is a huge job of which I take very seriously. In fact so seriously that in order to be able to dedicate the time and effort necessary to the job of Grand Master I retired from my day job of 39 years. I found it was interfering too much with my job as Grand Master. Seriously as you begin to work at this job it soon becomes very evident that without the support of very many people it would be impossible to do it. I know that I could not begin to mention every person by name who has helped me in this past year but I would like to say Thank You to everyone.

I would however like to first and foremost extend my sincere appreciation to my wife, The First Lady of Masonry and certainly my First Lady Janice and to coin a phrase first used in our presence down in the District 5 Joint installation ceremony in January where she received a beautiful bouquet of flowers and was unofficially given the title of Mrs. Grand Master. Not only has she attended with me to many Masonic functions in this past year but has faithfully supported me for the past number of years and stood by me with words of encouragement. Many hours of typing out reports and many other tasks too numerous to mention and though she isn't present in this room at this time she will and has had the opportunity to hear this report and accept our appreciation.

I would be somewhat remiss if I did not also say a special Thank You to VWB Buddy Trenholm for his dedication and work put forth not only as my #1 travelling companion but also the leadership when organizing us for the official visits and for all the notes recorded during the responsive sessions of my program at my official visits to the Districts.

I also have to say Thank You to RWB Bill Millett for all that he has done in not only this year but for years gone past in the work with our new web site to serving as DDGM to supporting and reporting on the youth and to being the head organizer of this year's Grand Lodge session and Grand Master's banquet and all that goes along with it and for many other jobs throughout our Jurisdiction.

Certainly there are so many others to thank that I could spend another half hour thanking the Brethren who sit on the Board of General Purposes, Grand Secretaries office, to the support of the elected Grand Lodge officers, to the DDGMs, to the appointed Grand Lodge officers, to the elected Masters and secretaries of their Lodges and on and on. We are all part of this team we call Masonry and I am very proud of each and every one of you.

I would also like to say thank you to all of our visiting guests of the other Grand Lodge Jurisdictions and the representatives of the concordant bodies. Your presence at our Grand Lodge session is not only appreciated but also very important and helpful in making our Grand Lodge session a success.

I feel I must report that I have been very well received at all our neighbouring Grand Jurisdictions both in Canada and the US with visits to 5 Canadian Grand Jurisdictions. One of which where I was extended the honour and privilege of bringing the greetings of all of the Canadian Jurisdictions present at the Grand Lodge of Canada in the Province of Ontario of which my theme was..."Size doesn't matter". I also had the distinct pleasure of being made an honourary member of the Grand Lodge of Prince Edward Island last June at their Grand Lodge session. A privilege I will always cherish. I also attended the 275th anniversary of Masonry in Canada in Annapolis Royal with the Grand Lodge of Nova Scotia where we marched in parade. I also attended the Grand Lodge of Quebec in Montreal and the Grand Lodge of Newfoundland and Labrador in Gander NFLD. In this past year I also attended 4 of our sister Grand Lodge Jurisdictions in the

Eastern Seaboard of the United States and because of conflicting events I had our DGM attend one of the US Jurisdictions and also our SGW attended one for us as well.

I have made official visits to 20 of the Lodges in which included 7 District meetings organized by the District Deputies of the 7 Districts in our Jurisdiction of which we were very well received and some excellent presentations of Masonic education were presented. I have attended many Lodge functions to present long service awards to a number of our members. I have also had the privilege of attending on our longest serving member of our Fraternity, Bro Harold Toole at his 101st birthday celebration. He is a member of Howard Lodge and is fast approaching his 80th year of Masonry. I also presented a long service medallion to Bro. Milton Palmer for 75 years of service to the craft. I am pleased to say that myself and through the help of others we have as a Grand Lodge been well represented at many Lodge sessions both in our Jurisdiction and our neighbouring Jurisdictions.

I am also very pleased to report that I believe we made Masonic history in our Grand Lodge Jurisdiction last June when I made my very first official visit as The Grand Master of New Brunswick to my Mother Lodge Westmorland #44 where there was in attendance approximately 100 Masons with representation from Nova Scotia and Prince Edward Island and was greeted and escorted to the East by the presiding Master WB Norman Allen who happened to not only be a brother but he is also my son. A very proud moment for us all. At that time I also took the privilege of placing the Grand Master's jewel upon the alter in honour of all those members of Westmorland Lodge who have long since laid down their working tools and joined the Great Architect of the Universe in the Celestial Lodge above as if not for those Brethren we would not have what we have today.

I would now like to report on a number of other projects going on within our Grand Jurisdiction which have taken place in this past year. Of course I would like to mention the ongoing support for Camp Goodtime and wish to thank all the Lodges who worked very hard throughout the year to support this very worthy project. Please continue to keep up the good work. We have a number of other projects like the hanging of the banners in recognition of our veterans in the community of St. George. Also the bikes for books from that area as well.

We have a committee in the Moncton area that have begun looking at a seniors housing complex as a not for profit project and are working very hard to see that this would happen. We have another committee working at the Grand Lodge level to begin organizing for the celebration of the 150th anniversary of Masonry in New Brunswick in 2017. I would also like to mention the excellent program produced by Rogers in the taping of the semi-public portion of our Grand Lodge session last year of which a copy of that CD was sent out to every Lodge in the Jurisdiction to be shared with the membership.

Another joint project we have in the making is an inter-provincial day to be hosted for the first time at my mother Lodge Westmorland #44 in Port Elgin. We have been granted approval by the Grand Master of Nova Scotia MWB George Grant and the Grand Master of PEI WB William Heffel to hold this event in late September. We will be opening the Lodge with NB officers and rituals. PEI will be presenting a Masonic education program and we will be closing the Lodge with the Officers of NS under NS ritual. We will then proceed to the banquet hall to share a meal and fellowship together. Since NS closed the meeting, the next September they will host the meeting, NB will be responsible for the Masonic education and PEI will close. We hope this will further strengthen our relationships with the 3 provinces and promote the fellowship of our Fraternity.

I would also like to mention at this time the honours and awards programs of our Jurisdiction. I have to say I was a bit disappointed in the Grand Master's awards program for this year having only a small number of our Lodges vying for and receiving this award. I feel certain that a much larger number of Lodges in this Jurisdiction are very much deserving and I may have failed to promote this as much as I should have this past year and certainly hope next year we will see an increase of applications for this award. On a more positive note I have it from a very reliable source, RWB Len Bishop the chairman of that committee, that we had a significant increase in the number of applications from the Lodges this year for the Quinn and Beardsley awards and also for Our Brothers Keeper and I am very happy to report on that. I am also very pleased to know that we now have a 3rd District that is promoting the challenge to their new Master Masons to strive to receive the Masters Mason Rookie Award and look forward to presenting them to those who have achieved that merit.

I am also very pleased to report upon the attendance of the All Canada Conference which we were well represented by myself, RWB Clyde Townes and our Grand Sec. RWB Randal Nelson. I was very pleased to report on the many projects going on in our Jurisdiction such as, the books for bikes, banners for veterans, the possible seniors housing project, our ongoing support for Camp Goodtime, our planned Inter-Provincial day with New Brunswick, Nova Scotia and Prince Edward Island, the Masters Mason Rookie Award Program and my program being presented at my official visits, District Meetings with Masonic Education and the engagement of the members present at the meetings, many of which generated discussion with me after the meetings. We were also given the opportunity to hear a number of great functions and projects being used in the other jurisdictions of which I will be sharing with those who are interested. As I stated in my presentation at the conference I believe we don't have to re-invent the wheel for if there are programs that are working in other Jurisdictions maybe we can make them fit to our needs as well and I closed my presentation by pointing out to them that "Size Doesn't Matter".

Well Brethren as you can see this was a very busy year in our Jurisdiction with a number of projects on the go and more to follow. I am especially pleased with the response and participation I have had with the program I have been presenting at my official visits and now that I have presented this program in every District in the Province and collected a wealth of information and responses from the Brethren, I will be putting that committee together as promised and we will sit down and thoroughly analyze the results and will do our best to report as soon as possible to the membership with the results and to implement and act upon as much as possible the suggestions put forth. For I truly believe that if we continue to remain positive and we work together as a team with a better understanding of what some of the greatest issues our Fraternity feels are facing us today. Support one another with visitation, Masonic education and 2 way communications and a genuine concern and care for our Brothers that we cannot fail and that Masonry in this Jurisdiction will be around for many, many years to come.

## ANNUAL REPORT OF THE N.B. MASONIC CHARITIES & HOUSING COMPANY LIMITED

To: The Most Worshipful The Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

It is my pleasure to present the Annual Report of the New Brunswick Masonic Charities & Housing Company Limited for the year ended December 31, 2013.

Camp Goodtime was made possible, once again with the presentation of a cheque for \$39,400 during the 146th Annual Communication of this Grand Lodge to Ms. Rosemary Boyle, Acting Director of Prevention and Support of the New Brunswick Division of the Canadian Cancer Society. Camp Goodtime is a seven-day summer camping program operated by the Cancer Society for children, aged seven to sixteen, with or

having had a history of cancer.

Due to the ongoing efforts of the members and lodges throughout the jurisdiction with their many fundraising efforts and generosity we are able to support this camp again in 2014. The cost of this camp will be \$39,400 the same as that for 2012 & 2013. The closing day for the camp, to which all Masons in New Brunswick have been invited, is Saturday, July 12 with the closing program beginning at 10:30 a.m. The camp location is at the Rotary International Camp for children with disabilities on Route 690 on the north side of Grand Lake near Douglas Harbor.

Due to a reduction in the funds received in 2012 and to our commitment to Camp Goodtime, Camp Goodtime was the only charity supported in 2013. It is encouraging to see that a few of the lodges increased their focus and level of contribution in 2013 and that the major fundraiser in the Moncton area continued with their much appreciated fundraising activity.

Thanks to St. Marks Lodge # 5 in St Andrews and to those members who continue to manage the Quinn House in that community so well on behalf of our Grand Lodge.

## **REPORT OF THE BOARD OF GENERAL PURPOSES**

To: The Most Worshipful The Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

In accordance with the constitution, as your Deputy Grand Master a part of my duties requires that I chair the Board of General Purposes. The Board met four times since the last Annual Communication of Grand Lodge, June, November, February and March. The Board consists of The Grand Master and thirty eight members, twenty one which are by appointment and the remainder by virtue of the Constitution according to their title.

## First meeting – June 22, 2013

- 1. R:W:B: Clyde Townes, as Deputy Grand Master was elected as Chairman by virtue of the constitution. R:W:B: John Watson, Senior Grand Warden was elected Vice-Chairman.
- 2. Progression Study Committee was re-established with M:W:B: Miles Graham as Chairman.
- 3. M:W:B: Graham announced that the Mason's Day at Camp Goodtime would be held on July 13th 2013 at 10:30 AM. This is also the 25th anniversary of the GLNB hosting this Camp.
- 4. GM Awards. M:W:B: Allen announced the Committee would consist of himself, the Deputy Grand Master and the Senior and Junior Wardens. W:B: Macx MacNichol expressed his thanks for receiving "My Brother's Keeper Award" for Sussex Lodge, Number 4.
- 5. Membership. R:W:B: Watson was appointed Chairman of this Committee.
- 6. Public Relations/Mostly Masonry. W:B: MacNichol distributed a hand-out on "A Day at Grand Lodge 2013" concerning the Rogers Cable filming.
- 7. Ritual. This Committee will be reviewing the Funeral Service.
- 8. Training / Education / Planning. R:W:B: Burridge was named the Chairman of this Committee.
- 9. Youth. R:W:B: Millett reported there was a Demolay meeting in July.
- 10. R:W:B: Nelson reported on Income & Expenditure of Grand Lodge 2013. This resulted in a discussion on future Grand Lodge Communications.

## **Recommendation for Ratification: None**

#### Second Meeting – November 2, 2013

- 1. NB Masonic Charities and Housing. M:W:B: Graham had nothing major to report at this meeting. District 2 & 7 had a fund raiser for Camp Goodtime at Coverdale Lodge # 52 and \$20,000 was raised.
- 2. Foreign Relations. R:W:B: Black reported France is coming back on board.
- 3. Honours and Awards. R:W:B: Leonard Bishop reported that the application letters have gone out. There was a discussion regarding the lack of applicants for the awards.
- 4. Jurisprudence and Constitution. W:B: Scott Ellsworth explained the "Incorporation Act" of 1914 and its current impact on craft lodges.

- 5. Membership. R:W:B: Watson distributed a report which explained his committee has been formed and is in the process of collecting ideas and suggestions. Additionally, a request has gone out to all lodges through the Office of The Grand Secretary requesting some monthly statistics from lodge secretaries. This is currently being collected.
- 6. Proceeding. R:W:B: Hartford was absent. VW:B: MacDonald reported that the 2013 Proceedings have been received and are being distributed.
- 7. Public Relations / Mostly Masonry . W:B: MacNichol was absent but submitted a paper updating the current Mostly Masonry information, outlining additional work of creating photo albums on the website as well as reporting on the Rogers video taken at the 2013 Grand Lodge.
- 8. Progression Study Committee. M:W:B: Graham submitted an interim report to the Board with some discussion points for consideration.
- 9. Ritual. R:W:B: Arthur Young explained that the Committee is working on a review of the Funeral Service to address some concerns that have been raised in regard to proper reverence at these gatherings.
- 10. Training / Education / Planning. A detailed report was submitted by email from R:W:B: Burridge.
- 11. R:W:B: Nelson reported on the Secretaries' Meetings held the week previous.
- 12. R:W:B: Watson commented on R:W:B: Gillrie's book on the History of Lodge Buildings in New Brunswick. Brother Gillrie supplied a copy of this book to each lodge in the province. All proceed from the sale of this book is for Camp Goodtime.
- 13. R:W:B: Ross raised the question: Should Grand Lodge be helping Craft Lodges in its jurisdiction who need financial help?

## **Recommendation for Ratification: None**

## Third Meeting – February 1, 2014

- 1. It was noted that a thank you letter was sent to R:W:B: Gillrie and that the additional DVDs from Rogers were ordered.
- 2. M:W:B: Graham presented the findings of the Progression Study. It was recommended that "the current process remain in place". The committee further left two closing comments:
  - May be appropriate to consider amending the constitution to change the term of the Grand Master to a two year term it has become a time honoured tradition in this jurisdiction and consideration should be given to having it enshrined in the constitution.
  - Comment was expressed in regard to having time for the new Grand Master prepare for his term of office. Consideration be given to the implications of holding a semi annual emergent communication in the fall for the purpose of electing the Grand Lodge officers for installation at the following annual communication in May.
- 3. NB Masonic Charities and Housing. M:W:B: Graham presented a report from the Masonic Seniors Housing Committee which outlined in broad terms a plan to further investigate the possibility of building a Masonic Senior Housing complex in the Moncton area. Verbal support for the fund raising ideas for this proposal was expressed.
- 4. Grand Lodge Communication. R:W:B: Millett reported that all catering and hotel accommodations have been arranged.
- 5. Library. V:W:B: MacDonald reported that the committee is looking at some purchases. R:W:B: Laurie Bishop has submitted a list of suggestions.
- 6. Membership. R:W:B: Watson circulated a report. It laid out the decline in membership numbers and the low rate of lodge attendance. The committee asked that the Board of General Purposes consider make this issue its number one priority going forward.
- 7. Proceedings. Board Chairman R:W:B: Townes thanked, on behalf of the Board, V:W:B: MacDonald for his time spent in the preparation of the Proceedings for the past several years.
- 8. Public Relations/ Mostly Masonry. W:B: MacNichol was absent but submitted a report which reviewed the latest issue of Mostly Masonry and commented on how the Rogers CDs have been used successfully in education programming.
- 9. Sesquicentennial. V:W:B: MacDonald explained he is working on the idea of a historical exhibition in conjunction with the NB museum and to that end he is looking for artefacts from lodges.
- 10. Website. M:W:B: Allen led off the discussion by thanking M:W:B: Boone for his time and efforts spent

as Webmaster. He then reviewed the process of establishing a new website. R:W:B: Millett gave an overview of how the new site would work. M:W:B: Rattray moved an official thank you to M:W:B: Boone from the Board, seconded by M:W:B: Whittaker. There was a round of applause. M:W:B: Boone expressed his appreciation.

11. M:W:B: Allen will contact W:B: S. Ellsworth And Jurisprudence Committee to write a Social Media Policy.

#### **Recommendation for Ratification: None**

#### Fourth Meeting – March 8, 2014

- 1. In Memoriam for M:W:B: James H. Pike. Memoriam was spoken by R:W:B: Kierstead. Notices of Condolences received from other Jurisdictions were read and there was a moment of silence in remembrance.
- 2. Correction in the February 2014 minutes was noted Item 7 (b) should include R:W:B: Millett as Chairman of the Social Media Policy Committee in addition to the Jurisprudence Committee in the formation of a social media policy. Moved to approve the Minutes as corrected by R:W:B: Leonard Bishop. Seconded by R:W:B: Munn. *Motion carried*.
- 3. Progression Study. M:W:B: Graham moved, seconded by W:B: S. Ellsworth that the report be received and the 2 recommendations noted in the February 2014 presentation be pursued. The question was debated. M:W:B: Graham withdrew his original motion and made a second motion that the report be adopted without further action on the 2 recommendations. There was no seconder. M:W:B: Boone then moved, seconded by R:W:B: Flynn that the report and the recommendations be tabled indefinitely. *Motion carried.*
- 4. NB Masonic Charities and Housing. M:W:B: Graham presented several fund raising ideas and surrounding issues for discussion and feedback from the Board including casinos and bingos. R:W:B: Black moved that the Masonic Charities and Housing be granted blessing from the Board of General Purposes to pursue various fund raising activities. Seconded by R:W:B: Jefferies. *Motion carried*.
- 5. Foreign Relations. R:W:B: Black submitted a report that there had been Request for Recognition received from the following four lodges: The Regular Grand Lodge of Tahiti, the Grand Lodge of Macedonia, the National Grand Lodge of Guinea and the Grand Lodge of Baja California. All four lodges meet the requirements for recognition and have been approved by the Commission on Recognition of the Grand Masters. R:W:B: Black moved formal recognition of these Grand Lodges be ratified at the 2014 Annual Communication in May. Seconded by R:W:B: Laurie Bishop. This Recognition Ratification will be dealt with in the Foreign Relations Report.
- 6. Grand Lodge Communication. R:W:B: Millett reported that everything was on track for this year. Posters have been printed and the details are being finalized.
- 7. Honours and Awards. R:W:B: Leonard Bishop explained there have been many submissions received. He extended thank you to all of the DDGMs.
- 8. Jurisprudence and Constitution. W:B: S Ellsworth stated there was nothing new to report. There was discussion at this point requesting a list of suspensions be sent annually to all concordant bodies by the Office of the Grand Secretary with W:B: S. Ellsworth and M:W:B: Rattray suggesting this be discussed with the Grand Secretary.
- 9. Social Media. R:W:B: Millett provided a report to those present and recommended that it be adopted as a guideline for all GLNB membership in regards to any social media involvement. W:B: S. Ellsworth, as Chair of the Jurisprudence Committee, concurred with this recommendation. R:W:B: Millett moved that the Board of General Purposes recommend acceptance of the guidelines as presented and ratification of this Social Media Policy at the 2014 Annual Communication. *Motion carried*.
- 10. Membership. R:W:B: Watson presented his report as circulated to the Board. He reviewed the success the Grand Master is having as he solicits comments and suggestions regarding membership from regular Masons at the lodges he is visiting. It was suggested by the Chairman of the Board, R:W:B: Townes that R:W:B: Watson and M:W:B: Allen meet to formulate a plan to raise the priority of the membership studies and to develop a budget necessary to fund these activities. It was moved by R:W:B: Watson to approve the report. Seconded by R:W:B: Hartford. *Motion carried*.
- 11. Proceedings. R:W:B: Hartford explained that more future Proceedings will be produced electronically

as a cost reducing effort.

- 12. Sesquicentennial. V:W:B: MacDonald said there had been a letter sent through the Office of The Grand Secretary to all lodges asking for artefacts they would be willing to offer for display.
- 13. Youth. R:W:B: Millett said that the DeMolay program is doing well.
- 14. Other Committees Bursary. The Grand Master asked M:W:B: Rattray to succeed M:W:B: Pike as Chair of this Committee. The updated 2013 bursary form was circulated. Moved by M:W:B: Rattray and seconded by R:W:B: Laurie Bishop this new form be approved by the Board of General Purposes. *Motion carried.*
- 15. Land Purchase. R:W:B: Hartford presented the offer to purchase a small parcel of land owned by Grand Lodge in Upper Mills. It was the site of Alley Lodge # 14. The offer of \$ 500 was received from Herbert Jesso who owns the adjacent property. It was moved by M:W:B: Balsar that the offer be accepted with the provision that the buyer, Mr. Jesso, pay all transfer costs. Seconded by R:W:B: Kierstead. *Motion carried.*
- 16. Website. R:W:B: Millett reviewed the site and explained its development was progressing well and he is trying to accommodate requests for additions as they are being received.
- 17. Hands Across the Border. R:W:B: Watson talked about the event which is planned for St. Stephen / Calais on August 9, 2014. There was some discussion and questions for R:W:B: Watson.
- 18. Non Resident Application. W:B: S. .Ellsworth reviewed the item as it relates to a current situation and asked for any suggestions. R:W:B: Hartford cited a similar earlier case during this time of Grand Master Hitchcock. It was decided to ask the Grand Secretary to work it out with the Grand Secretary of Nova Scotia.
- 19. Review of the May 2013 Constitutional Amendments. M:W:B: Boone distributed a report. The first portion of the report outlined errors / omissions in the 2013 Proceedings. M:W:B: Boone moved acceptance of the first portion of the report. Seconded by W:B: S. Ellsworth.
- 20. W:B: S. Ellsworth also suggested that the Board consider establishing a Committee to Review the Proceedings prior to publication and that the Annual Communication agenda include a "Motion to Confirm the adoption of the Minutes of the last Annual Communication as printed and distributed".
- 21. R:W:B: Ross inquired about any Lodges within the Jurisdiction who are having difficulties with membership / finances. He wondered if Grand Lodge is consulted regarding prevailing issues and solutions being considered. The Grand Master said he had met with one lodge in the province which is experiencing troubles.

## POLICY REGARDING SOCIAL MEDIA AND NEW BRUNSWICK FREEMASONS

The Grand Lodge of New Brunswick recognizes that social media has grown exponentially in recent years and has a goal of supporting the regular and extensive use of it. We know that many Brethren regularly connect by Facebook, Twitter, LinkedIn and other means. We as Masons must be mindful that our individual postings not only reflect our own character but that of Freemasonry across this Grand Jurisdiction.

### Social Media Policy

- A Mason should conduct himself with the same courtesy he would in front of the general public.
- As a Mason, he must be aware that his postings are a permanent record; therefore, his conduct may influence the world with a positive or negative opinion about him personally and about the organizations to which he belongs.
- A Mason should never use disparaging comments, profanity, etc. when posting; including, but not limited to, graphic, video, and audio recordings.
- A Mason should not post "ritual" or "tyled" information.
- Masonic pages are to be supportive of the organization and its members, promote upcoming events, discuss past events, video sharing, and discussion of times of fellowship and promotion of Masonic bodies.
- A Mason should not use Social media to obtain personal advantage in promoting political, religious or business activities by targeting other Masons.
- A Mason should not use social media to contact other Grand Jurisdictions unless you are a member of that jurisdiction. Remember that all intra-jurisdictional communication is, by Masonic protocol, conducted by and between Grand Lodge offices.
- No discussion or other information regarding to an application, background, or investigation of an applicant is ever appropriate or condoned.
- There should never be discussion regarding the ballot on a candidate.
- Nothing should ever be written or discussed relative to the business of a Lodge or of any discussions/ actions which have occurred behind Tyled doors.
- Masons should advise a Brother if something he has posted is improper within the framework of our Grand Constitution, Rules and Regulations, etc.

Ultimately, your actions as a Mason online should promote the highest standards of morality and integrity. You should always be mindful of the penalties as described in the Grand Constitution relating to trial, suspension, and/or expulsion for any un-Masonic behavior. Posting a comment related to the Fraternity and then posting a disparaging comment about a social or political stance can easily be misconstrued by readers that your stance is representative of Masonry and all Masons. Remember that the public and members of the Masonic Fraternity are reading your posts online.

## **Relevant Sections of the Constitution**

**115.** Publication of Proceedings – No brother shall presume to print or publish, or cause to be printed or published, the proceedings of any Lodge or any part thereof, or the names of the persons present at such Lodge, without the permission of the Grand Master, under pain of being reprimanded, suspended or expelled, as the Grand Lodge shall determine. This law is not to extend to the writing, printing or publishing of any notice or summons issued to the members of a Lodge, or by the authority of the Master, or the proceedings of any festive or public meeting at which persons, not masons, are permitted to attend.

**117.** Suspension of Membership – Every Lodge has the power of suspending or excluding a member for unmasonic conduct or for non-payment of dues, but no Lodge shall suspend or exclude any member for unmasonic conduct without giving him due notice of the charge preferred, or complaint made against him, and of the time appointed for its consideration. He shall be at liberty to be present, and be afforded every

opportunity of defending himself. When the case has been investigated he shall withdraw, and the votes of the brethren shall be given by ballot. It shall be the duty of the Master of the Lodge to ensure that the member against whom the charge or complaint has been presented is treated with fundamental fairness in all proceedings and, before any Masonic Trial is held, that every reasonable effort at mediation and settlement of the charge or complaint has been undertaken.

**176.** Offence by Lodge – A Lodge offending against any law or regulation of the craft, to the breach of which no specific penalty is attached, shall, at the discretion of the Grand Lodge, or the Grand Master, be subject to admonition or suspension.

**177.** Copyright Offence – No member shall, on any pretense, exhibit or expose any representation or similitude of any jewel or furniture of a Lodge, or of any Masonic emblem or device in any way that may be interpreted as for personal or commercial gain. Violation of this section may result in reprimand or suspension by the Lodge, or expulsion by the Grand Lodge. All members are strictly enjoined to immediately bring this offence to the attention of the brother involved. If corrective action is not taken a report shall be made to the Lodge to which the offending brother belongs.

**178.** Complaint by member – All complaints of members or difference between them, that cannot be arranged privately, or in some regular Lodge, shall be reduced to writing and delivered to the Grand Secretary, to be submitted to the Grand Master, who shall refer them to a Committee to investigate the same. When all parties shall have been summoned to attend thereon, and the case has been investigated, the committee shall report to the Grand Master, which shall have full power to deal therewith as a majority shall determine. Any complaint against a member shall be presented without undue delay and shall specify with sufficient particularity the details of the alleged Masonic Offence together with the sanctions sought to be imposed.

## **REPORT OF THE TRAINING, EDUCATION & MENTORSHIP COMMITTEE**

To: The Most Worshipful The Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

It is with pleasure that I submit this report on behalf of the Training, Education and Mentorship Committee. We began this year with an interest in creating a document that would summarize the types of Education and Training activities that are occurring in the lodges throughout the jurisdiction. We were able to identify programs that are in effect in Districts 1, 2 and 7. While I am sure that lodges throughout the jurisdiction have Education and/or Training programs there were none who responded to our requests for input.

District 1 -Albion Lodge #1 has begun a process of intentionally inserting a longer length of time between degrees than we have experienced in recent years. An essential part of that process is the presentation of "papers" by both Master Masons and the candidates for the various degrees. This has had the effect of creating the "need" for education based on the degree ritual and lectures.

Districts 2 and 7 have used a Leadership Program to study the GLNB Constitution, Ritual and Officers' Manual. The program has developed to be one that also looks at the meaning and background of various Masonic topics generated by participants. This has been occurring for about 3 years and the attendance has varied depending on the time of the year and the topic being discussed. The sessions are scheduled every 3 months. Also, every 3 months, is a smaller Discussion Group that meets to speak about understanding and viewpoints about Masonic research, writing, videos, etc. Both of these programs have generated a loyal and interested following.

What has become abundantly clear to me in the course of this committee's work this year is that there is little that the GLNB can do to "make" Education and Learning take place. The best that the GLNB can do is to encourage and to express a vision of the centrality of Masonic Learning. Over the past years, a number of programs on Mentorship, Training and Education have been developed and have been well documented. Copies of the documentation exist at the GLNB Library.

Lodges can be encouraged to provide education and learning opportunities but often, it seems that these words are used with no common understanding of the meaning. It is worth taking the time to differentiate between Training, Education and Learning. It is also worth the time to actively support and monitor the constitutionally required mentorship program.

As we go forward, it is my recommendation that we encourage and monitor the implementation of programs at the lodge level that address training and learning needs. With support, lodges can develop schedules that

involve officer and member training early after the installation of the Master and his officers. From there, the schedule for the year can build on degree ritual and "papers" that are presented on a variety of Masonic issues. This type of program has been shown to be highly successful in sister jurisdictions and lodges that dedicate themselves to this mission but it doesn't just happen. It requires work, planning and organization. The Grand Lodge can support the lodges through their District Deputies.

Education, Training, Learning and Mentorship will occur with the fervency and zeal that is devoted to it. If we make this a central aspect of our vision of Freemasonry then the opportunities for the development and implementation of highly effective and worthwhile programs increase dramatically.

Who knows what effect this can have on attendance and membership? If the experiences of some of our sister lodges spread over North America, South America and Europe are any indication, it is very positive.

Since it's inception in 1919, DeMolay has counted on the committed support of the entire Masonic Family and young men have benefited greatly by their association with Masons. For many young men the first impression of Masons or the world's oldest and largest fraternity may have come through their involvement in DeMolay. What better way could there be for a young man to receive a positive impression of our fraternity by being permitted to "rub-elbows" at a young age.

DeMolay teaches the seven cardinal virtues; love of parents, reverence for sacred things, courtesy, comradeship, fidelity, cleanness, and patriotism. The seven cardinal virtues of DeMolay are consistent with Masonic teachings because the ritual of DeMolay was written almost 100 years ago by a Scottish Rite Mason.

DeMolay will never, by itself, solve the Masonic membership problem, but it might solve the Masonic leadership problem. Exposing young men to the good works of Freemasonry and teaching them by example the tenants of our profession as a mason and teaching the useful skills of organization and leadership will benefit our fraternity, our country and our young people. DeMolay claims to do all of these things and there are many examples of our success. The Grand Lodge of Connecticut proudly boasts 12 of the last 48 Grand Masters are Senior DeMolay.

DeMolay, unfortunately, is not self-sufficient or self-sustaining financially. The young man joins DeMolay and pays a life membership fee of \$50. We never want the financial bar of joining to be set so high as to preclude a member. There are no annual dues. Chapters plan their own activities including fund-raising. The costs of running DeMolay far exceed the abilities of the Chapters to raise sufficient funds. DeMolay is incapable by its design, to exist without Masonic monetary support. Our members do not have full time jobs and don't get the ability to make tax deductible donations. We live, and die, on the generosity of our benefactors. Investing in DeMolay is investing in our future.

Then there is the need for adults, masons, the "Mentors" to the young men of DeMolay. We can sometimes count on a father figure to become involved with his son, but a large percentage of our members come from broken homes. DeMolay has one of the highest standards in youth serving organizations for providing supervised and safe opportunities for young men to grow, to learn and to have fun. With high standards, comes the need for adults. Not just any adults, although we will take help from any adults who pass our screening process, but more importantly Masons. Masons are one of the most important things in the DeMolay world. Masons already have begun to understand the ideals and principles of Brotherly love relief and truth, the virtues of temperance fortitude prudence and justice.

The very same principles and virtues DeMolay hopes will be instilled in some great or small way in it's members.

DeMolay teaches young men the ideals and principles of good son-ship and good citizenship. Ideals of leading clean upright manly and patriotic lives, worthy of the commendation of all good men. We hope that

we, the masons who volunteer our time, can lead by example of always trying to do good and to be better. We hope that the lessons learned while involved in DeMolay, will help them to make the right choices and decisions as they go forward in their lives.

I receive comments from parents about the involvement of their sons in this organization, usually verbally, but sometimes in writing. I'd like to share one of them with you today.

"My grandson has been a member for about one year. Yesterday I had a birthday party for his Great grandmother (my mom) who will be 85 soon. I was amazed at my grandsons help --he served people sweets and juice, was available to carry packages and chairs and all in all a great help to me. I called this am to thank him and his Mom and she tells me he is taught some of this at DeMolay I just want to thank you and let you know that your time spent with these young men is paying off. Both my dad and my husband's dad were Masons in Edmundston 40 years ago. I am not sure what type of programming you do with the young men but should you need something please let me know."

Yes Masonry has a tremendous amount to gain from youth, and how much it has to give. These boys and young men should epitomize the high hopes of Masonry in a world in which the ideals of Masonry will be needed with increasing urgency, and in which those ideals have to be guarded with an ever increasing zeal.

Are the boys conscious of all these things we have discussed? Of course they are not. A past Grand Master put it well when he wrote, "No boy ever joins any organization, engages in any activity, or seeks any experience for the purpose of improving his character. " Character, is a by-product of wholesome activities participated in under competent guidance. But that character, the sum total of all the moral virtues we can instill into youth in general, is the most important armour this nation, or any other, ever had. When we lose that in our young people we are doomed to destruction.

Any youth movement sponsored by Masons would have to have as its purpose the inculcation of high ideals, and the creation of ways and means toward that end. The organization available to us is dedicated to that high purpose. It is important that at the beginning of every chapter meeting a boy open the Holy Bible on the altar, speak of religious tolerance and remind his brothers why he does so. It is equally important that immediately following, another boy lay school books on the altar, reminding his brothers what the public schools mean to youth, and then the flag of our country is presented and the importance of patriotism is expressed.

On Many fronts Masonry is facing the most crucial challenge of its long and venerable history. None is more important and none will be more far reaching, than the way it meets its challenge to Youth. That boy today is the citizen and Mason of tomorrow. That boy who ran across your lawn and trampled your flowers could be tomorrow's hero. But he'll be a better citizen, a better Mason, and is more likely to have what it takes to be a hero, if he has a helping hand from you today.

Brethren, I believe it is important that we do more than watch passively while this Masonic youth movement grows. I believe we should help it grow. By helping, I mean volunteer your time, your talents and your financial support.

Franklin D. Roosevelt said; "We may not be able to prepare the future for our children, but we can at least prepare our children for the future."

## **REPORT OF THE GRAND HISTORIAN**

On August 4, 1914 Great Britain declared war on Germany, close on the heels to this declaration Canada followed suit when on August 5th the Governor General of Canada Field Marshall His Royal Highness the Duke of Connaught announced Canada's declaration of war. That Canada was automatically at war in support of Great Britain was unquestioned as from coast to coast Canadians pledged support for the Motherland. Sir Wilfred Laurier spoke for the majority of Canadians when he stated "It is our duty to let Great Britain know and to let the friends and foes of Great Britain know that there is in Canada but one mind and one heart and that all Canadians are behind the Mother Country"

With a regular army of only 3,110 men and a fledgling navy Canada was ill-prepared to enter into a world conflict, however, the call to arms was met with thousands of Canadian men flocking to recruiting stations across the country. Within a few weeks thirty-two thousand men had descended upon the Valcartier military camp near Quebec City. Within two months the First Contingent of the Canadian Expeditionary Force was on its way to England and into a war the likes of which had never been seen or experienced in the history of man.

This was a war that was to shape the modern world. It was at Verdun that the notion of mass destruction was pushed to its limit for the first time. The 1914 war was a culmination of a nineteenth century that increased the productive - and destructive- power of mankind beyond the scope of dreams and nightmares. It was a war fought with numerous inventions, machine guns, high powered artillery, poison gas, tanks, planes and fragmentation shells all designed to kill and maim.

During the next four years of the war over 600,000 Canadian men and women would be mobilized and sent overseas. Of these some 67,000 made the ultimate sacrifice while another 250,000 were wounded. Names of battles like St. Eloi, the Somme, Vimy Ridge and Passchendaele would become permanently etched in the Canadian psyche. It should also be noted that the Canadian victory at Vimy had far more reaching implications than that of a mere military achievement. The victory at Vimy while costly in terms of human lives (over ten thousand Canadians fell to enemy fire) it also served to shape a young nation. The victory



caused immense pride back home. Canadians had begun the war as colonials, as subordinates, but were now Allies; they had succeeded where others had failed.

While the war was raging in Europe at home the day to day activities continued on, always with thoughts of loved ones and friends (or in the case of our fraternity their brethren) serving overseas. At the annual Grand Lodge communication held August 25, 1914 the Grand Master M:W:B: Frederick Knowlton had these remarks in his annual address regarding the recent declaration of war:

"Since the above was written, a state of War has been declared between six of the greatest nations of the world, and, at the present moment, the continent of Europe is one vast armed camp.

One of the missions of Masonry is to teach the doctrines of peace, because they lie very near to the heart of this organization, and therefore a war such as this must bring grief to the whole Fraternity throughout the world. There is, however, one foundation stone upon which, more than upon any other, our structure securely rests, and that is duty or loyalty to one's own country. This is a cardinal doctrine of all true Masons, and, while we deplore the strife, . yet we who own allegiance to the crown and throne of England rejoice that Great Britain has lifted the gage of battle to enforce and compel the keeping of treaty obligations, and to preserve the integrity and rights of smaller nations,- speeding perhaps more quickly the day of final disarmament. This war to our Empire is not a war of conquest, but a defence of right, and from it may we not hope shall flow the last great peace which shall endure forever.

Our prayers go out to the Great God of Battles that from this war in which we are engaged, and from which we could not shrink, we shall emerge triumphant to carry again the wide world over the message of peace, to uplift humanity amongst all races and classes of mankind."

The tone set by M:W:B: Knowlton in his address would continue over the next several years. At the annual communication of Grand Lodge held in April of 1916 M:W:B: Hedley Bridges included the following in his annual address:

"The year that has passed has been one of supreme importance in the history of the world. Momentous events have occurred since we last met, and while the time has been filled for us with absorbing duties, there has been ever with us a full measure of anxiety.

Fondly did we hope, fervently did we pray, when we parted here over a year ago, that the horrors of this awful war would be measurably removed and the horizon brightened for us before another annual communication. But the Supreme Architect of the Universe has decreed it otherwise, and this war which has been waged with relentless fury for the past twenty months continues to be carried on by those who deliberately planned it with a cruelty and savagery unsurpassed in the history of warfare, and with a preparation the efficiency of which has astonished the civilized world.

In common with other parts of the British Empire and our Allies, Canada is suffering losses that cannot be estimated in the death of so many of her brave sons on the field of battle. It has been estimated that Masons to the number of 10,000 have enlisted for foreign service. I have not, however, statistics at hand to place before you.

But we, as Masons, bow reverently to the will of the Supreme Master, calmly awaiting the final result, with supreme confidence that in His hands rests the final arbitrament of the appeal to arms, and that He will still uphold our great Empire battling in defence of liberty and civilization, of treaty obligations and the sacred rights of humanity, and that truth, the divine attribute, is still mighty and will prevail."

As we approach the anniversary of the commencement of the First World War we should never lose sight of the sacrifices that were made during that devastating four years. No historian or author of any genre can find the words, no matter how eloquent they might be, to describe what these Canadian fighting men endured while serving on the front lines. We should also remember that amongst the fallen were members of Lodges in this jurisdiction who made the ultimate sacrifice and their names are to be found at the end of this report in the form of an honour roll. May their sacrifice never be forgotten and may they rest in peace.

In Flanders fields the poppies blow Between the crosses, row on row, That mark our place; and in the sky The larks, still bravely singing, fly Scarce heard amid the guns below. We are the Dead. Short days ago We lived, felt dawn, saw sunset glow, Loved and were loved, and now we lie In Flanders fields. Take up our quarrel with the foe: To you from failing hands we throw The torch; be yours to hold it high. If ye break faith with us who die We shall not sleep, though poppies grow In Flanders fields.

## **REPORT OF THE FOREIGN RELATIONS COMMITTEE**

To: The Most Worshipful The Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

#### **Requests for Recognition**

The following four requests for recognition were received this past year:

#### Grande Loge Nationale Guinéenne

(National Grand Lodge of Guinea)

The United Grand Lodge of England extended recognition to this lodge in 1998 and in the 1999 the Commission for Recognition Report states "The Commission considers the Grande Loge Nationale Guinéenne to be regular and entitled to recognition". Therefore the Foreign Relations Committee proposes that at the 2014 Annual Communication, the Grande Loge Nationale Guinéenne be granted recognition.

### Muy Respetable Gran Logia de Estado "Baja California"

(Grand Lodge of the State "Baja California")

The Request for Recognition was received from this Lodge in Mexico by order their Grand Master José Guzmán. This lodge has been recognized by several US States and a few other Canadian provinces. It is Listed in the 2013 List of Lodges. From the 2013 Commission for Recognition Report "There continues to be two groups that claim to be the legitimate Grand Lodge of Baja California. After further review, we would like to see both sides reconciled, however the Grand Lodge of Baja California, under Grand Master José Guzmán currently meets the standards for recognition." The Foreign Relations Committee proposes that at the 2014 Annual Communication the Muy Respetable Gran Logia de Estado "Baja California" (Grand Lodge of the State "Baja California") be granted recognition.

#### **Grand Lodge of Macedonia**

"The Grand Lodge of Macedonia was concentrated on September 20, 2005 in Skopje by the United Grand Lodge of England...This Grand Lodge is regular in its work, and meets the standards for recognition." 2006 Annual Report form the Commission for Recognition. Thus the Foreign Relations Committee proposes that at the 2014 Annual Communication the Grand Lodge of Macedonia be granted recognition.

#### Grande Loge Reguliere de Tahiti et des archipels

(Regular Grand Lodge of Tahiti and Archipelagoes)

The official request for recognition was received in March 2012. They were constituted in December 2011 from three lodges previously chartered by the Grande Lode Nationale Française. In 2012 the Commission for Recognition felt that "this new Grand Lodge practices regular Masonry and is a sovereign territory...and meets the standards for recognition." However, there was some ambiguity concerning a claim by the Grande Lode National Francaise and last year the Foreign Relations Committee delayed this request. The Grand Lodge of Tahiti, upon receiving our decision last year, sent another request with more documentation. Whilst it still has a connection to France this area is internationally referred to as an overseas county due to its degree of autonomy so the Foreign Relations Committee will accept the Commission's findings of "sovereign territory" and recommend recognition at this time for the Grande Loge Reguliere de Tahiti et des archipels.

### The Grand Lodge of Turkey

The Foreign Relations Committee recommends recognition for this long-established lodge be formally granted at the 2014 Annual Communication to create an official record in the Proceedings for which documentation appears to have been overlooked many years ago.

# **REPORT OF THE PUBLIC RELATIONS COMMITTEE**

To: The Most Worshipful The Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

#### **Public Relations**

The Public Relations Committee continues to be put forth the positive aspects of the Fraternity of Free and Accepted Masons of New Brunswick throughout the province.

These efforts are being done through joint cooperation in supporting projects between other public organizations. These efforts not only include the Public Relations Committee but also individual lodges. These endeavours include the tri-annual publication of Mostly Masonry.

A prime example of how a lodge in a local community can become involved in jointly supported projects is how St. George Lodge # 12 recently participated with the Royal Canadian Legion Branch # 48 of St. George, NB. That project honoured Canadian Veterans through displaying banners honouring individual veterans from the local area. (Reported in the newspaper the "Courier", Charlotte County, Oct. 01, 2013).

Another initiative which is under development is an opportunity for a fundraiser proposal by Casino New Brunswick, in Moncton, which would be in support of the New Brunswick Masonic Charities and Housing Corporation (N.B.M.C.H.C). Plans continue at the time of the writing of this report (26 Mar. 2014) with the final package to be published upon completion within weeks.

These initiatives partially address "some" of the present issues facing the Fraternity and may permit it to maintain the long standing activities in difficult times.

Another initiative in a small community of joint participation, which other lodges may be doing, is how Sussex Lodge # 4 has joined resources of the graduating classes from the local Regional High School over the past three (3) years. This corporation permits existing projects to continue within a small community and by a lodge with limited resources.

It is imperative for lodges to make the local community in which they reside aware of projects and any upcoming major events in which the general population can participate as well as any significant historic aspects of that may have links it to the history of the at very same community. Efforts also continue to provide information to media outlets to provide human interest stories which may carried by local Radio stations and newspapers. Many reports on activities are submitted by individual lodges throughout the province similar to the ones previously mentioned in this report.

The PR Committee continues to encourage individual lodges be visible within communities in a positive participating style.

## Mostly Masonry

Mostly Masonry in 2013 included three editions (winter, spring and fall) which continued to express the views of a number of brethren, attempted to inform and entertain by having with such sections as a book section as well as a section of scheduled dates of special events being organized by the individual lodges.

REPORT OF THE MEMBERSHIP COMMITTEE

To: The Most Worshipful Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F & A.M.

As the 2014 session of Grand lodge approaching signals the end of another Masonic year. At this time we the Membership Committee would like at this time to take the opportunity to express our pleasure to having served The Most Worshipful Stephen H. Allen. Officers and members of Grand lodge this past year and looking forward to the privilege for the coming year.

Looking backwards over the past year it appears little gains have been accomplished regarding the membership issues, we're still dealing with the sharp decline in membership that has virtually continued unabated since 1961. We don't have clearly defined directions regarding policy, identifying problem areas and issues enough to lay out a workable plan nor have we a means to accurately monitor results as they occur. There is much to do before we strike out implementing initiatives hoping to turn our craft around.

This committee however was active through this past year, persistently collecting data on membership numbers from the year end reports, particularly for the 2003 -2013 period as well as ideas and suggestions from many members of the craft. We also listened carefully and noted many of the suggestions solicited by the MW and given by the membership during his official visits around the jurisdiction. Late last fall via the Grand secretary's information sessions, a request from the committee to have each lodge secretary submit the number of members and visitors attending each lodge session was given, although approximately (16) lodges complied with the request and are still faithfully passing their numbers along, the lodges that have submitted their numbers have proved useful.

Having sifted through the information received thus far there are at least a few recommendations this committee can offer just now that may help us identify and lead us to a solution for some of the issues before us ...

- The membership reporting system should be reviewed with thoughts of making some major improvements ie: timelier reporting, more accurate information and providing greater accessibility to the membership at large.
- The membership Committee should be meeting regularly (face to face) for some period till a workable plan can be laid out and implemented, then somewhat less regularly to ensure the monitoring of plan, policy etc. is maintained ...
- The committee should have the Grand Secretary and staff with the office resources available to ensure the official and authority necessary to maintain the forward path a committee of this stature requires ....
- A reasonable budget be assess for the committee to help offset some of the traveling costs

that will be incurred for attending meetings.

All is not bad within our jurisdiction of course, all of North America and Britain are suffering under the same issues most of which are precipitated by the rapid decline in membership, which regrettably will not slow for some time yet, if at all. However there are good things happening throughout our jurisdiction. Several lodges are dealing with issues in their own particular way with initiatives tailored to their situations and needs with some success.

An interesting observation was made at a recent lodge meeting from the master of a lodge where he stated that improvements with our graft has got to come from the lodge members themselves and he phrased his comments to suit the craft using those famous words of President JFK "Ask not what the Grand Lodge can do for us, rather ask what we can do for the Grand Lodge" ... If we all had that view our problems would be as nothing!

Put simply we the Grand Lodge can set policy, put forth ideas and initiatives and put in place a system of monitoring successes or failure and provide accurate and timely reporting by using all the social media methods available to us today and continue to move forward with fresh new ideas all the while respecting and encouraging the individual lodges right to their own methods that works best for them ...

#### **REPORT OF THE GRAND LODGE PROGRESSION COMMITTEE**

To: The Most Worshipful Grand Master and Members of the Grand Lodge of New Brunswick, F & A.M.

The subject of progression to Grand Lodge Offi has come up at the Board of General Purposes on a few occasions (1982, 1989/1990, & 2002/2003) with the decision of the Board on each of these occasions not to entertain a notice of motion to change the constitution. A committee was formed in 2012 and reported to the 146th Annual Communication with the recommendation that the work be deferred until after that session. This committee submitted reports to the BoGP November meeting with a follow-up report in February after receiving input from a few board members with the BoGP addressing the committee reports at their March meeting. Please note that any comments in reference to this subject is in regard to this jurisdiction - GLNB and is no refl on any other jurisdiction as their rules, history and status are unique to each of them.

In the jurisdiction of the Grand Lodge of New Brunswick all members of Grand Lodge who have been regularly installed and served at least one year as Master of a lodge in amity with this Grand Lodge are eligible for every elective offi in this Grand Lodge. (Constitution Article 12)

Written nominations for the several elective offi of Grand Lodge, as mentioned in the constitutions, shall be deposited with the Grand Secretary no later than 60 days prior to the opening of Grand Lodge. Such nomination is to include a brief account of the Nominee's craft Lodge background which will be published in the proclamation calling Grand Lodge. (Regulation 1- Section 1)

This election process provides fl in options and timing to anyone with aspirations for elective offi which may not be possible in a progression mode, and also benefits Grand Lodge and its membership by permitting involvement of more individuals. The individual has the option of progressing through the elective offi or to select whichever offi he is interested through submission of his nomination, subject to vote of the membership through the election process. Very few Brethren have held the offi from JGW through to the Offi of Grand Master.

Similar situations have taken place where individuals have held an elected Grand Lodge offi and have not continued with the offi but have been active on committees, in their Craft lodges and in support of Grand Lodge and the fraternity. This is an opportunity for an individual to take on a challenge, to learn and develop and perhaps decide if he wants to proceed and in the process he will undoubtedly be a greater asset in whatever capacity.

This process begins with the individual making the decision that he has something of value to off by letting his name stand for elective offi by submitting his nomination. The decision then rests with the membership in becoming familiar with those nominated for the elective offi as to direction, plans etc., to attend and to vote. Grand Lodge voting members have for years made choices that they believe are in the best interest of Freemasonry.

It is the recommendation of this committee that the current process remain in place based on:

- 1. The ancient charges (Landmarks) recognize that the government of the fraternity by a presiding offi called a Grand Master, who is elected from the body of the craft. To change that to say the Grand Master ascends to that specific offi by virtue of having held another violates not only the letter of the ancient charges but the spirit and integrity as well.
- 2. This process has been in place in this jurisdiction since its inception and there is every indication that it has worked well. We have all heard the expression -"If it's not broken why fix it".

A couple of comments in closing:

- 1. May be appropriate to consider amending the constitution to change the term of the Grand Master to a two year term It has become a time honored tradition in this jurisdiction and consideration should be given to having it enshrined in the constitution.
- 2. Comment was expressed in regard to having time for the new Grand Master prepare for his term of offi Consideration be given to the implications of holding a semi-annual emergent communication in the fall for the purpose of electing the Grand Lodge offi for installation at the following annual communication in May.

*Note:* The Board of General Purposes after reviewing and discussing at the March board meeting decided to continue with the current process.

It is with pleasure that I submit this report summarizing my first year in the office of District Deputy Grand Master for District-1.

At the beginning of 2013, the eight Blue Lodges of District-1 had a membership total of 729 masons and by year end we numbered 677, a loss of 52 masons. Sadly twenty-one of these have passed to the Celestial Lodge above. Their memory we cherish in our hearts. On a more positive note Brethren, Freemasonry marches on in the District as can be attested to by the addition of eighteen new Apprentices into the Craft.

Some of the fund-raising events and activities coordinated and carried out by our various Lodges in the District are as follows:

*Albion Lodge #1* The Lodge initiated 2 Apprentices, issued 3 demits and suspended 1 member. Masonic education papers were delivered on "The Obligation of the First Degree"; "Masonic Etiquette" and "the Fellow craft Degree." Our first Agape was held in November-2013 followed by two more in February and March -2014 respectively. "Agape" is a Greek word for "Love" and so an agape could be described as a gathering together in Masonic love and fellowship for the purpose of education, discussion and the exchange of ideas. In January the Lodge held a joint installation with St. Martin's Lodge #30.

*St. John's Lodge #2* The Lodge initiated 2 Apprentices, affiliated 1 member, issued 2 demits and suspended 2 members. The Lodge organized and carried out a Spring Social to celebrate the widows of the Lodge and hosted local artists along with their displays during Saint John's "Harvesting the Arts Festival". Prior to Christmas they had hosted the annual "Tibbs Eve dinner." This Lodge holds two Saturday morning meetings monthly, with the focus on mentoring and Masonic education. During the latter part of the summer St. John's Lodge held their first annual Masonic softball game. The weather cooperated and good fun and brotherhood was shared by all. As a side note, some of us older brethren paid dearly over the next week for thinking that "we still can." This gathering was such a success and a fraternal magnet, that we are thinking of organizing it on a grander scale to include all the Lodges in District 1. Who knows, it could evolve as a baseball tournament between Districts.

*Hibernia Lodge #3* The Lodge affiliated 1 member, demitted 2 and suspended five brethren for NPD. The Lodge is planning a "Widows & Ladies" appreciation dinner in the Masonic Temple banquet room this May. The Lodge held a Whisky tasting workshop last year that proved quite successful and subsequently raised funds for Camp Goodtime. A tradition of this Lodge has been to man the Christmas kettles for the Salvation Army every December, as it has in the past and plans to for many years to come. As it has historically, this Lodge will again be involved significantly in the planning and preparation of the seven course meals, enjoyed by all at our annual Temple Table Lodge.

*Carleton Union Lodge #8* Unfortunately this Lodge has suffered a decline of 20 members due to deaths, demits and suspensions. On a positive note, they have initiated two new members and still maintain a total of 150 members. One of the senior members, Brother Merle Rumson had attained centenary status (100 years of age)) before passing. He had been a member of the Craft for 75 years and I must mention here, as I knew him personally, a good hearted, solid gentleman who survived an ordeal that many of us would never want to contemplate; that of being torpedoed on a Corvette, in the North Atlantic, while serving in the R.C.N during World War-2. Per tradition, the Lodge presented fifty dollar bursaries and plaques to two students at Beaconsfield Middle School. The annual Turkey Dinner fundraiser was held in the Fall and raised \$2700. The Lodge continues to successfully canvass for individual donations in support of Bobby's Hospice and the West Side Food Bank. The kitchen committee continues to prepare and serve dinners

on a monthly basis, enhancing fellowship amongst the members and the visiting brethren. Through the chairmanship of W.B. Gary Caines the Lodge is developing a five-year plan for its future operation. Of worthy note, Carleton Union Lodge had a 74.2% attendance for voting at the Grand Lodge Communication; the best in the province.

*The Corinthian Lodge #13* The lodge initiated 4 new members, affiliated 1, had 2 reinstatements, 7 demits and sadly had four brethren pass to the Celestial Lodge above. The Lodge continues having monthly dinners at each communication and is renowned throughout the Fraternity, in the province, for its "strawberries & cream" in July. A Divine Service was held by the Lodge on June-22-2013, a 50 year award bestowed on Br. Bill Brittain in July and the "Order of the Rusty Nail" carried out for Br. Tom Hoyt. The Lodge held a "Ladies Night" in November and a Christmas carol service in December. This Lodge has just completed extensive renovations to the Lodge entranceway and washrooms utilizing the in-house labour, time& skill-set of several brethren. As a result, the costs were kept in line with Lodge affordability. The workmanship was of high quality and reflects the kind of output that can be achieved when brethren pull together and the Worshipful Master literally "sets the Craft to work."

*Zion Lodge #21* In 2013 the Lodge initiated 1 new apprentice, demitted 4 and had 4 members suspended for NPD. They hosted eight Senior Suppers which raised just under \$5000. Funding for the Lodge upkeep and maintenance also flows from rents derived from the Crokinole Club, Pythian Sisters, Kiwanis Club, Royal Arch Chapter 9 and the Luxor Shrine. In June the Lodge hosted the annual BBQ with their wives and guests. They normally hold an annual Christmas Party for the children, which unfortunately had to be cancelled this year, due to two snowstorms.

*New Brunswick Lodge #22* The Lodge initiated 3 new members, affiliated 1, demitted 2 and suspended six brethren. On a sadder note, four of the Lodge brethren passed to the Celestial Lodge above. On June-22-13 the Lodge hosted a Master Mason degree at Beaver Lake. The degree was conferred on one brother in a successful outdoor ceremony conducted by R:W:B: William Ryan. During the regular November communication a "Past Masters' Night" was held with R:W:B: David Ross presiding in the East. R:W:B: Whitcomb, Treasurer of Masonic Charities & Housing , presented a history of Camp Goodtime, along with a video of Freemasonry and its charitable work. PGM, Most Worshipful Brother Miles Graham delivered closing remarks on Camp Goodtime. In December, an update on the" Widows' program" was presented by R:W:B: Mayes. A one thousand dollar donation was made to NB Masonic Charities & Housing towards Camp Goodtime from New Brunswick Lodge #22. The Worshipful Master of the Lodge, R:W:B: Scott Bastarache stated that: "NB Lodge will continue its focus on strong ritual work, education, membership involvement and working toward the future of masonry."

*St. Martin's Lodge #30* The Lodge has raised 3 new Master Masons having an average age of 40 years old and have three new officers in line of progression towards Worshipful Master, who are all under 30 years of age. In 2013 their fundraising for Camp Goodtime netted \$889 and the Lodge also awarded four \$500 bursaries to local students.

*The District #1* Golf Tournament held in September-2013 although not supported well by the wet weather was well supported by the District 1 Lodges, they having each purchased a hole for \$100 each. Proceeds from the event were donated to Camp Goodtime.

On December-13-2013 a Table Lodge was held at the Masonic Temple, under the Charter of Albion Lodge #1 and hosted by the well-experienced Officers of NB Lodge #22. This was another successful evening for Freemasonry, in which Past Grand Master, MWB Miles Graham, representing Masonic Charities & Housing, was presented a cheque for \$10,705 as a result of funding received in the District from the 2012/2013 District Golf Tournaments along with donations received from several Lodges previously mentioned in this report.

Three Official visits of the Grand Master, MWB Stephen Allen took place in District #1 during the May 2013-May 2014 period as follows: The Corinthian Lodge #13 on August-14th, Carleton Union Lodge on

December-5th and just recently to St. Martin's Lodge# 30 on March-24th.

In closing, I would like to extend my thanks and gratitude to all the Masters, Wardens and Brethren of the District 1 Lodges for their fine support and cooperation during my 2013 "Break-in period" and a special thanks goes to the Past and Present serving Grand Lodge Officers, without whose support and mentoring the District 1 Officer Installations would not have been carried out so successfully.

The opening of the Masonic Club at the Moncton Temple on Sept. 6, 2014 has been a source of fellowship in the area, and has been a great success due to the dedication of many of the brethren within the area; they are to be congratulated for their initiative. The Travelling Gavel Banner was presented to Lodge St. Andrew in February, as they had accumulated more points than any other lodge within District 2 & 7. The format of the criteria for the Travelling Gavel is under review. *Sussex #4.* There is a growing concern as to the future of this lodge, as the demographics of this area has seen an aging population, with younger people moving to the urban areas in search of employment, although, the membership that remains work diligently to keep this very beautiful and unique temple in good repair. They are a stalwart to their community, and I am sure a very good example shown of our fraternity.

*Lodge St. Andrew #16.* As with many rural lodges, this lodge is not as active as it once was, however the members are very dedicated, great visitors, very well versed in ritual and conformity to proceedings and protocol. Even though the membership is very small, it is very rare that the offices are not filled with the installed officers. This shows their dedication.

*Keith # 23.* As the highest membership of any lodge within the district, it has much degree ritual to do, and although they are able to do their degree work, they have a good balance of education included in their meetings. It is, though, rather disappointing that there is not a better representation of the craft at their regular meetings. This is a point that the current Master is working on, as he would like to put all the Craft to work.

*Zetland #24.* For the first time in 5 years, Zetland has had 2 brothers raised to Master Masons in the last year. Most of its members are active, and known within their community as members of the Masonic fraternity, whether through their annual church service, or through their activity at the local senior's residence.

I look forward to serving and representing the Grand Master within district # 2 during the upcoming year. In closing, I would like to thank those brethren who have come along with me in my travels to the various lodges, and all those who supported me in my official visits, it is, and will continue to be what will make our fraternity strong. Although, there is concern on the quantity of members, I am convinced that this Fraternity is meant to be made up of Quality and not Quantity. Through history, the fraternity has seen its rise and fall in numbers, but because of the quality of those dedicated masons, it has survived longer than any other fraternal organization in history.

#### REPORT OF THE DISTRICT DEPUTY GRAND MASTER DISTRICT 6

To: The Most Worshipful The Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

I am writing to you today in accordance with Section 55 of the Grand Lodge of New Brunswick Constitution and Regulations regarding the "State" of each Lodge within my Jurisdiction. They are as follows:

*Hiram #6, Fredericton, N.B.* – This Lodge is quite healthy with a membership of 152 Brothers. Since my appointment as DDGM they had three new Petitions in June, plus an additional two petitions and two Affiliations since then and are currently balloting on three more Petitions in the Month of April. As well, they have an Application for Affiliation from a Worshipful Brother Craig Thompson from the Grand Lodge of England. Hiram Lodge has an attendance of between 25 and 35 Brothers at their monthly Communications. Hiram Lodge #6 is doing well.

*Alexandria Lodge #33, Fredericton, N.B.* – This Lodge is doing well with a membership of 132 Brothers. They started out with one reinstatement plus another Application for Affiliation in June and received three new Petitions in September. The MM Degree was conferred on Dec 2nd, 2013. In January 2014 WB Peter Ramage, Past Master, presented a "Candlelight Service" and Aprons and Grand Lodge Certificates were presented to Brothers NAZ, Taylor and Milton by R.W.B. Len Bishop, Past District Deputy Grand Master. Alexandria Lodge donated \$1,000.00 to Benjamin Lodge in Perth-Andrew in 2013; issued three Life Memberships in February 2014 to Brothers Vernon Fraser, William Kane and Bro Claire McMillian. Alexandria Lodge is having a Widow's Dinner on May 30th, 2014. This Lodge has a very active and creative Social Committee that normally put on a dinner each month in conjunction with their communication. Alexandria Lodge #33 is doing well.

*Sunbury Lodge #42, Fredericton Junction, N.B.* – This Lodge is struggling to survive and has a membership of only 34 Brothers. They have only had two new Petitions (Carter and Johnson) since May of 2013. They put on a very successful Widow's Dinner in June but had to move from their current location to the Town Community Center in December of 2013 as they could no longer afford to heat their Lodge Building as their main tenant, the local Bank, cancelled their storage agreement. As a result Sunbury lost over \$4,800.00 in revenue and had to close during the months of January and February in order to keep afloat. They now have been given accommodations, by the City Council, in the Tri Centre Community Centre at a cost of \$50.00 per month which will help tremendously with their finances. They are now in the process of attempting to sell the old Lodge Building. However, all their problems notwithstanding, Sunbury gave out two Bursaries this year. One to a Julian Cormick and another to a Matt Malory. In March of 2014 the District Degree Team put on the MM Degree for a Jeromy Woodside. Sunbury Lodge #42 is a struggling Lodge who are putting their best foot forward.

*Gr. Lake Lodge #47, Minto N.B.* – This Lodge is in trouble and has difficulty in fielding sufficient members to come out and serve on a regular Communication evening. They have a small membership of only 45 Brothers. Sometimes they are only 4 or 5 members present which requires visitors to fill Stations in order for them to have a Quorum to open. I have personally filled in positions of Tyler, JD, JW, and SD. They have had one new Petition this year (Scott Young). The Lodge put on a successful Widow's Supper in September which brought in \$200.00 net. They currently have no Secretary and no Stewarts. The newly installed suite of Officers are working diligently to encourage other members to come out and serve but are not successful so far. Time will tell if Gr. Lake Lodge #47 will have to surrender their Charter!

*Cherry Mountain Lodge* #50\_ – This Lodge is doing well and has a membership of 83 Brothers. They had three new Petitions (Wishart, Rehz and McKeighan) in September of 2013 and have since then received two more Applications for Affiliation from an Erin Dunsmore and a Roy Sellars. They have put on a Valentines Supper raising over \$1,200.00 for Camp Goodtime and are currently working on a Curling Bonspiel to take place at a cost of \$120.00 per team with no curling experience needed. On October 10, 2013 they hosted the MWGM on his Official Visit. There were 55 Brethren present. Cherry Mountain Lodge #50 is a very active

and efficient Lodge who are doing all the right things.

*Landmark Lodge #51, Boiestown, N.B.* – This Lodge is alive and well holding many fundraisers including a Widow's Night in November 2013 with 66 members and Widows present; their annual Golf Tournament plus Surf & Turf on August 17th, 2013 and their Curling Bonspiel in January of 2014. They are currently fundraising for a Spring Fishing Trip which includes dinner plus a personal guide for which much of the proceeds will be donated to Camp Goodtime. Landmark is well known for ritual work and was the only Lodge to open on the 11th by memory that I have witnessed in District #6. Landmark has 85 members and usually has an average of 25 to 30 Brothers at their monthly Communication. Since May they have had one new MM (Bro Kent Davis) and one new petitioner, Matthew Ross who is currently away on a Truck Driving Course. Landmark Lodge hosted the Most Worshipful Grandmaster at its Monthly Communication on November 19, 2013. A Candle Light Ceremony was conducted in February of 2014 by R.W.B. Laurie Bishop, Past Senior Grand Warden. It was very well received. Landmark Lodge #51 is doing all the right things and are alive and well.

*Granite Lodge #54, Temperance Vale, N.B.* - Granite Lodge is struggling to stay alive. They have a small membership of only 49 Brothers, however, they continue to fundraise for Camp Goodtime and were also able to donate \$1,000.00 toward the restoration of Benjamin Lodge in Perth-Andover over the past year. They are situated in the Community Center of the Village of Temperance Vale, NB and thus have little overhead with the exception of their monthly rent which only amounts to \$100.00 per month. In spite of their small numbers they were able to put on a very successful Widow's Dinner which was well attended. In 2010 the then WM, WB Gale Rae instituted an "Award" for visitors showing up to Granite Lodge for the first time. This award is a Granite Rock which is attached to a White Rectangular Board stating that you have been "Rocked" at Granite. Since its inception in 2010 they have had something like 126 Brothers who have been "Rocked at Granite". I had my first Official Visitation at Granite Lodge back in February 2014 and it was well attended. Granite Lodge is struggling to survive but I am confident that with a little luck and perseverance they will be around for some time.

As many of you are aware, the term of the District Deputy starts half way in to the year of the lodges in the district. This afforded opportunities for me to become involved with the lodges during the second half of their year. The lodges in District 7 are sister lodges to District 2, and it has often been called District 27. This past year has been no exception. The lodges continue to work together on joint fundraising projects including the infamous Camp Good Time 50's and 60's Dinner and Dance held each fall. It is interesting to see the brethren of different lodges coming together, upholding that basic tenant of our profession, Brotherly Love.

The district continues to hold monthly meetings for 3 different purposes. First as a District Education

meeting, where various topics of Masonic protocol or floor work or delving into why we do some of the things the way we do, even to the point of discussion on topics surrounding our history and philosophy. The second meeting is the Discussion group where anything goes. The topics range from books to general interest to anything in general someone wants to talk about with his brethren. Third are our District Council meetings where all the lodges in the two districts are represented. Topics range from the travelling gavel to the notices of Motion before Grand Lodge, from upcoming events and fundraisers to setting a date for a leadership training seminar, and all things relative to lodges in general. My counterpart, R.W. Bro. Steeves and I co-chair the council meetings and we have each valued the involvement and the harmonious interaction of our lodges.

During this past year I have made official visits to each of my lodges as well as several unofficial visits. I have attended on the Official visits of the Grand Master in District 7 as well as District 2 and several other visits. The Grand Masters Official visit to our District was very well attended in Harmony lodge with Brethren from District 5 chartering a bus to attend. It was a great night for Masonry. The lodge room was full, a sight not seen for many years. The presentations put on the Masters of my lodges were well done and thought provoking. The Grand Masters questions continued to prompt the interchange of ideas between the brethren. No one can remember the last time a lodge meeting in Harmony lodge, or any lodge in District 7, closed at 11:00 pm in Peace and Harmony with the brethren still discussing the ideas put forward, and wondering where the evening went.

All of the lodges are providing education to the brethren and I understand are all seeing new members requesting applications to join our fraternity. In general all of the lodges are holding their own against the general decline in membership. While there is still a lot to do on this front, the work is being done and the efforts will bear fruit in the near future.

I wish to thank The Most Worshipful The Grand Master for affording me this educational experience of being his representative in this district. It is a great honor and privilege and something I will be grateful for, for many years to come.




*Note* - in 2012 Grand Lodge reviewed the Grand Representative Program and made the following decisions:
